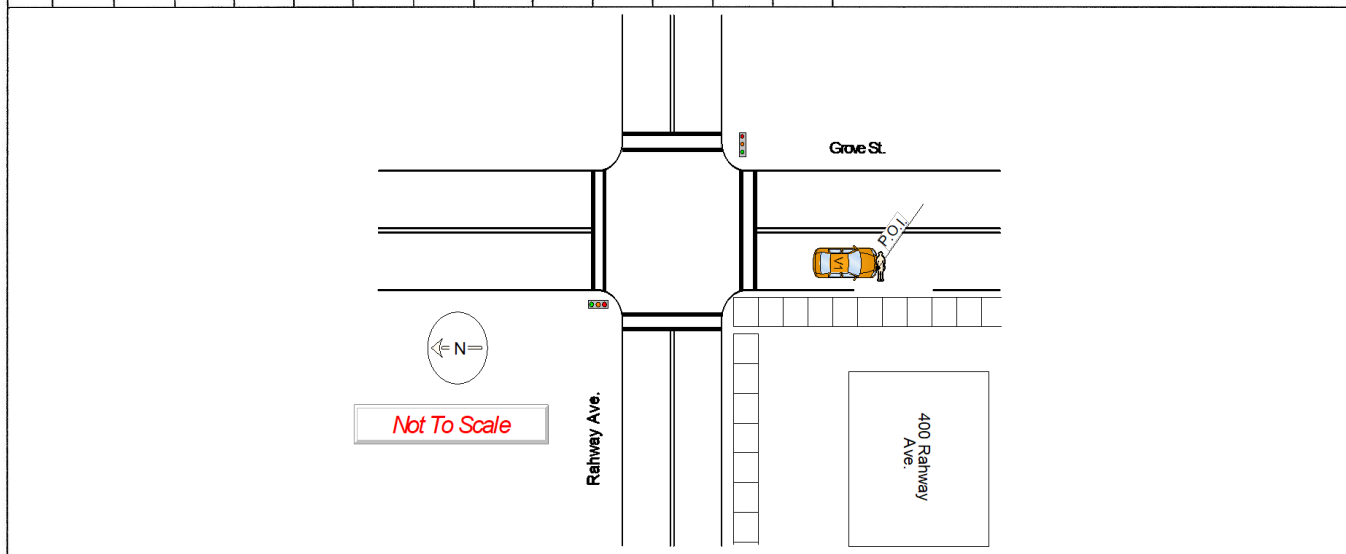

145. Crash Description/Narrative

Driver of Veh. 1 states she was traveling South on Grove St. As she crossed over the intersection of Grove St /Rahway Ave. she states she heard her vehicle strike something around the area of the driveway of 400 Rahway Ave (Grove St. side). It was at this time she had struck a pedestrian crossing the street.

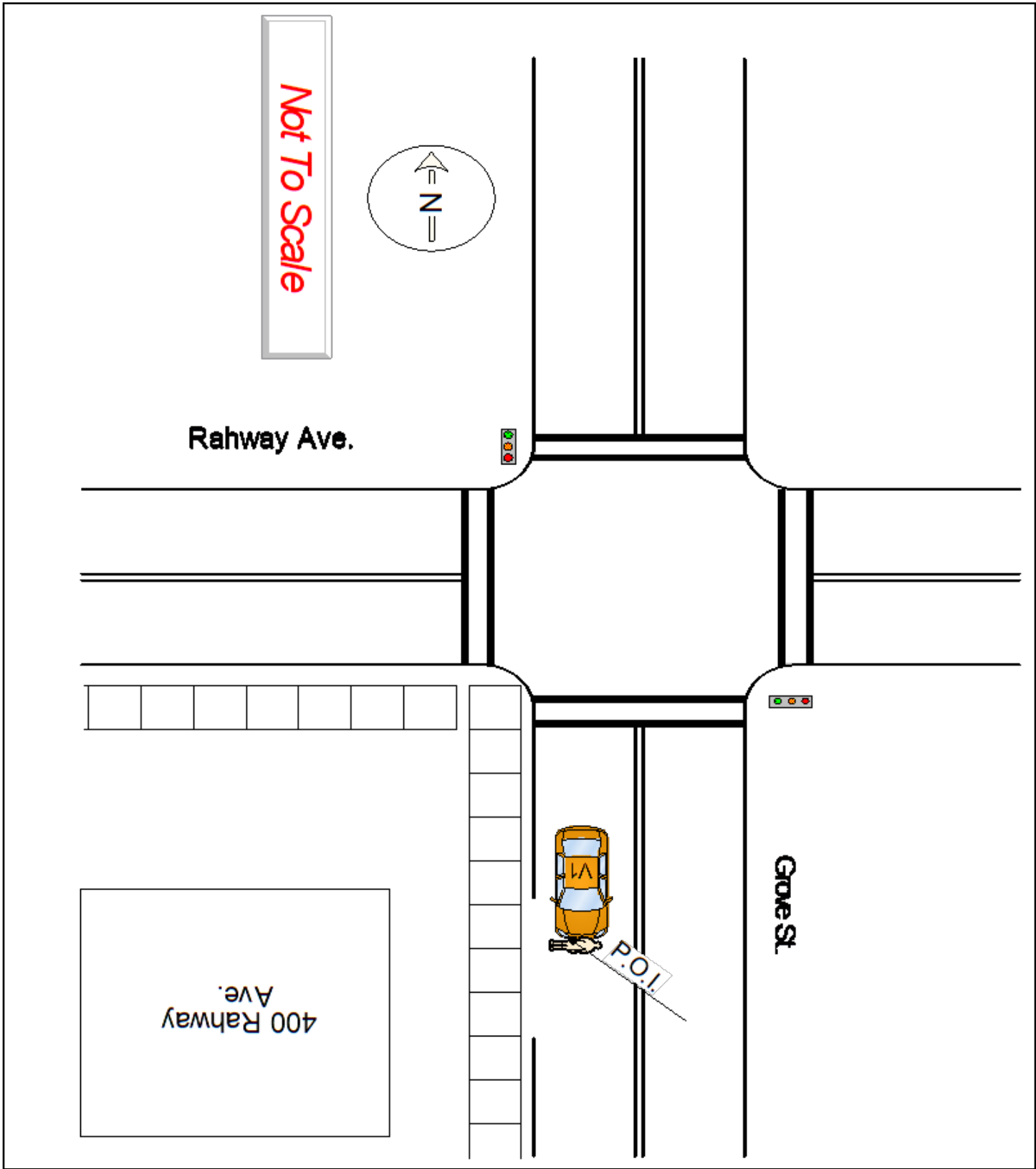
Pedestrian states she was crossing the street at the intersection of Rahway Ave /Grove St. in the crosswalk heading East when she was struck by Veh. 1 who was traveling South on Grove St.

A witness states she observed the accident as it happened. Her statement states she observed Veh. 1 traveling South on Grove St. at which time Veh. 1 struck the pedestrian. She states the pedestrian was crossing over the middle of the block by the driveway of 400 Rahway Ave.(Grove St. side) not the crosswalk. She states the pedestrian hit the front of the vehicle and flipped over the top of it.

Pedestrian was transported to Trinitas Hospital for evaluation. An incident report was created under same case number BWR available on scene of accident but not inside of the hospital
