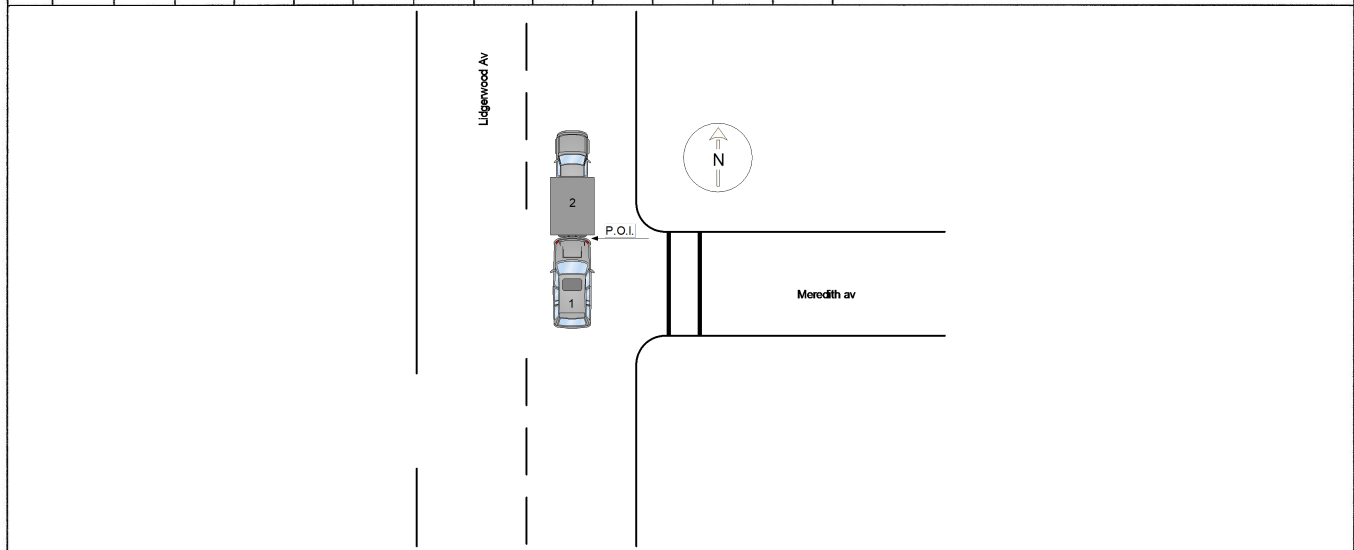

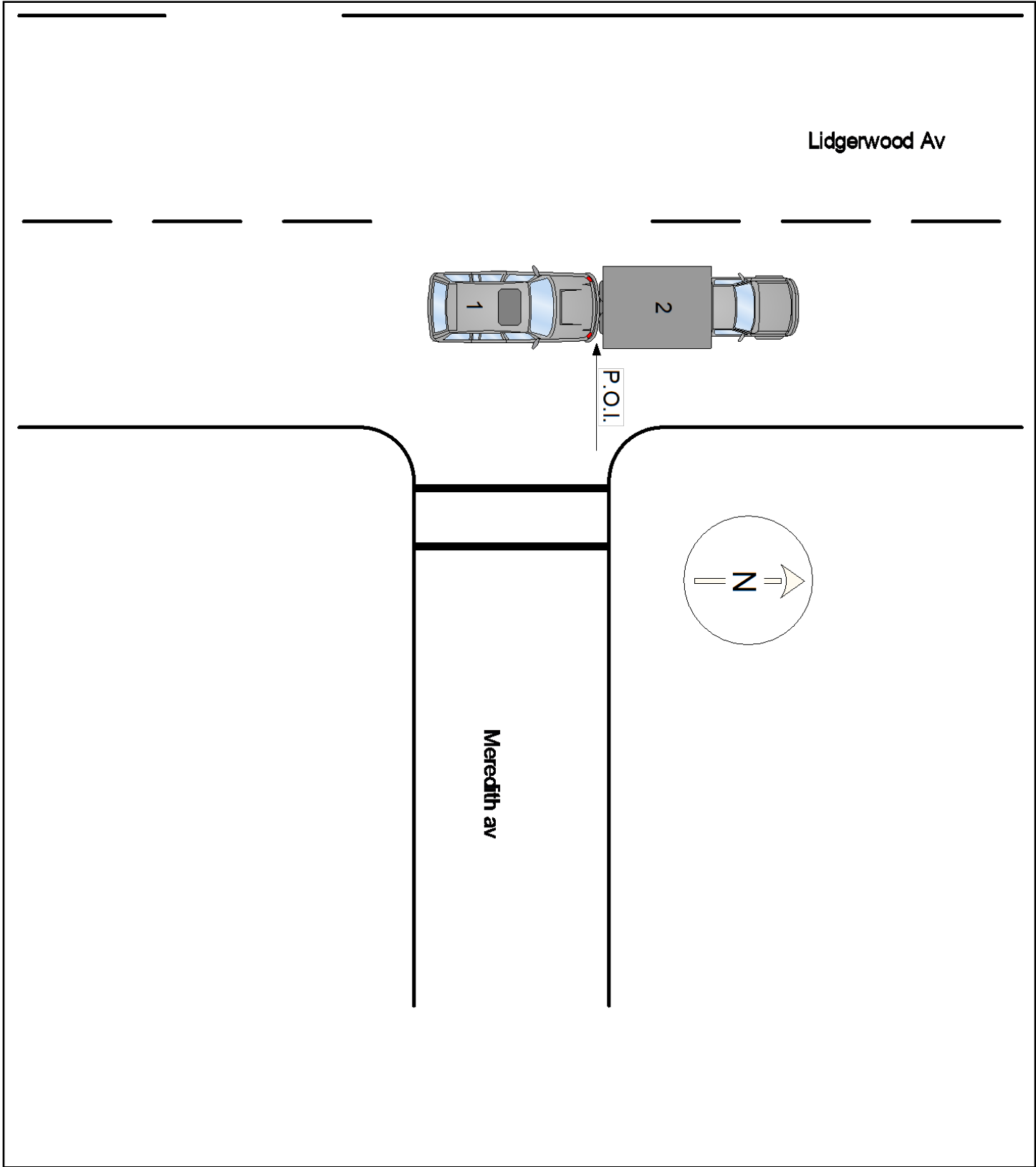
Driver of vehicle #2 states as he was slowly traveling north on Lidgerwood Ave, he was struck by vehicle #1 on the rear.
