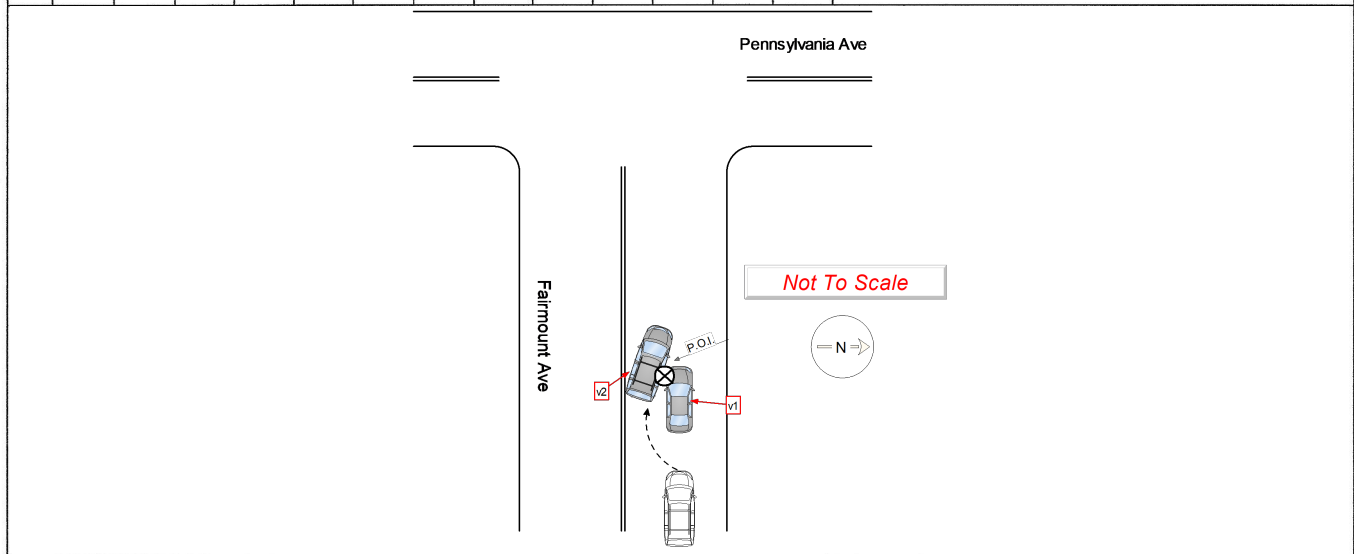

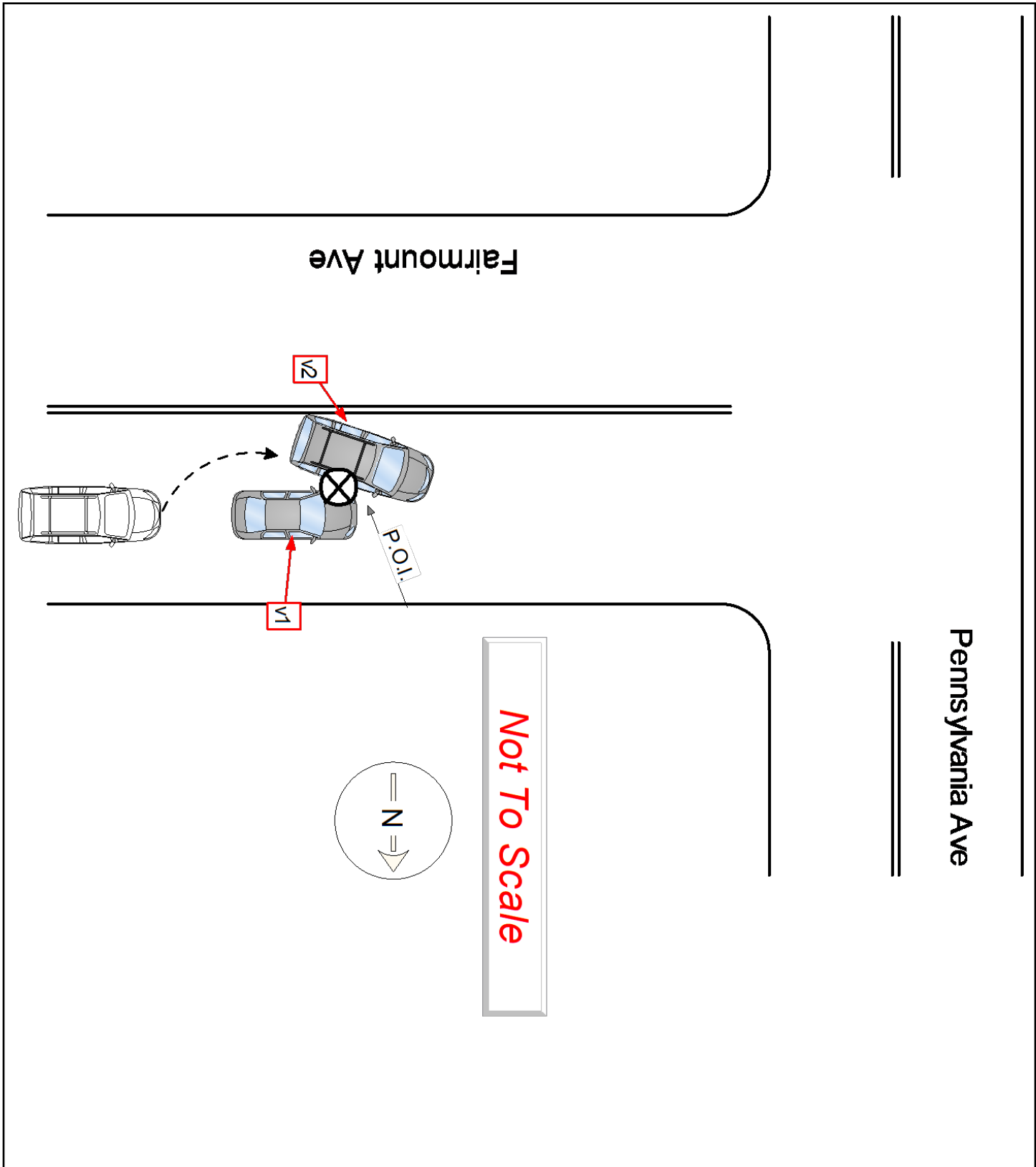
145. Crash Description/Narrative

Driver of vehicle 1 stated that she was traveling West on Fairmount Ave while she was proceeding in traffic. Same stated that as the vehicles in front of her began to move forward there was space between her and the car in front of her. As she began to proceed, driver of vehicle 2 attempted to pass her on the left lane, striking her vehicle on the drivers side front bumper, causing minor damage. Driver of vehicle 2 stated that he was traveling West on Fairmount Ave, waiting in traffic behind vehicle 1. Same stated that he was waiting for vehicle one to proceed yet she remained stopped while traffic was continuing on, in front of vehicle 1. Driver 2 stated he then tried to go around vehicle 1 in the left lane, at which time she began to proceed, causing v2 to strike v1 causing minor damage to the passenger side of v2. All parties refused medical attention, and were advised accordingly. Summons was issued to driver of V2.
