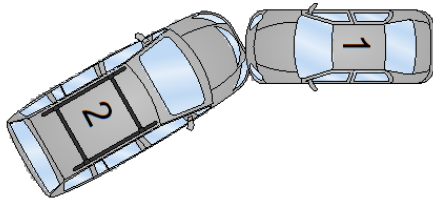
Driver of V1 states that as he traveled east on York Street, he was cut off by V2 who caused the collision.

Driver of V2 states that as he attempted to make a left turn into the driveway of 546 York Street, he was struck by speeding V1. BWR

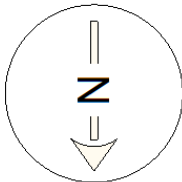
