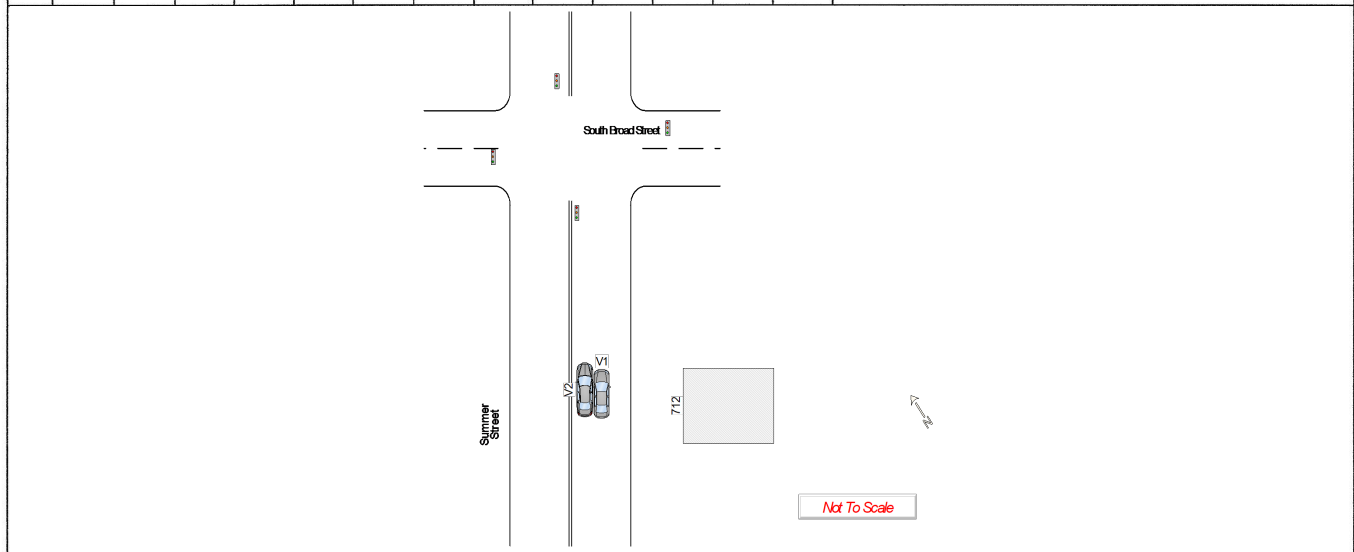

145. Crash Description/Narrative

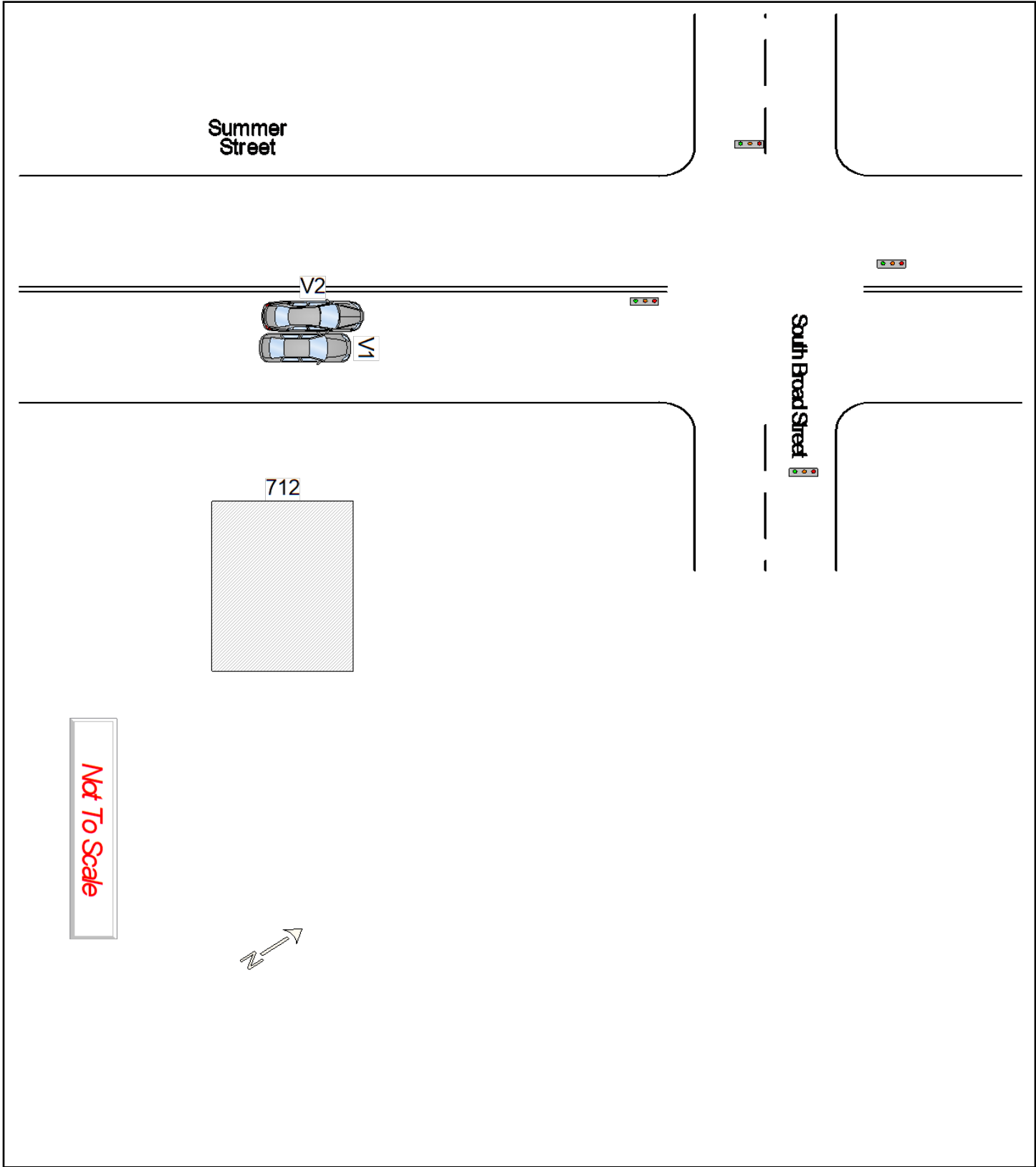
Operator of vehicle one states she was traveling on Summer Street when the operator of vehicle two passed her on the left and made contact with her vehicle.
