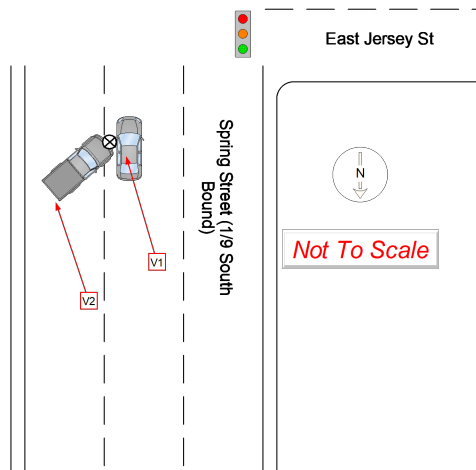

145. Crash Description/Narrative

D1 Stated that he was traveling South bound on Spring Street (1&9) in the middle lane approaching the intersection of Spring Street and East Jersey Street. Same stated that is when he observed V2 begin to turn in the direction of the middle lane from the left lane. D1 stated that he attempted to stop his vehicle by breaking to avoid the collision, but due to the wet raining conditions he could not. D1 stated that V2 continued to turn into the middle lane where V2 struck V1 in the drivers side door and quarter panel. D1 further stated that D2 then reversed his vehicle and began fleeing the scene. Same was able to provide the following vehicle information and license plate. A red Dodge pick up truck bearing NJ registration L 40-LRU. D1 stated he followed him for a couple of blocks in an attempt to get him to stop, but was ultimately unsuccessful. The following summons were issued and mailed to Z2:

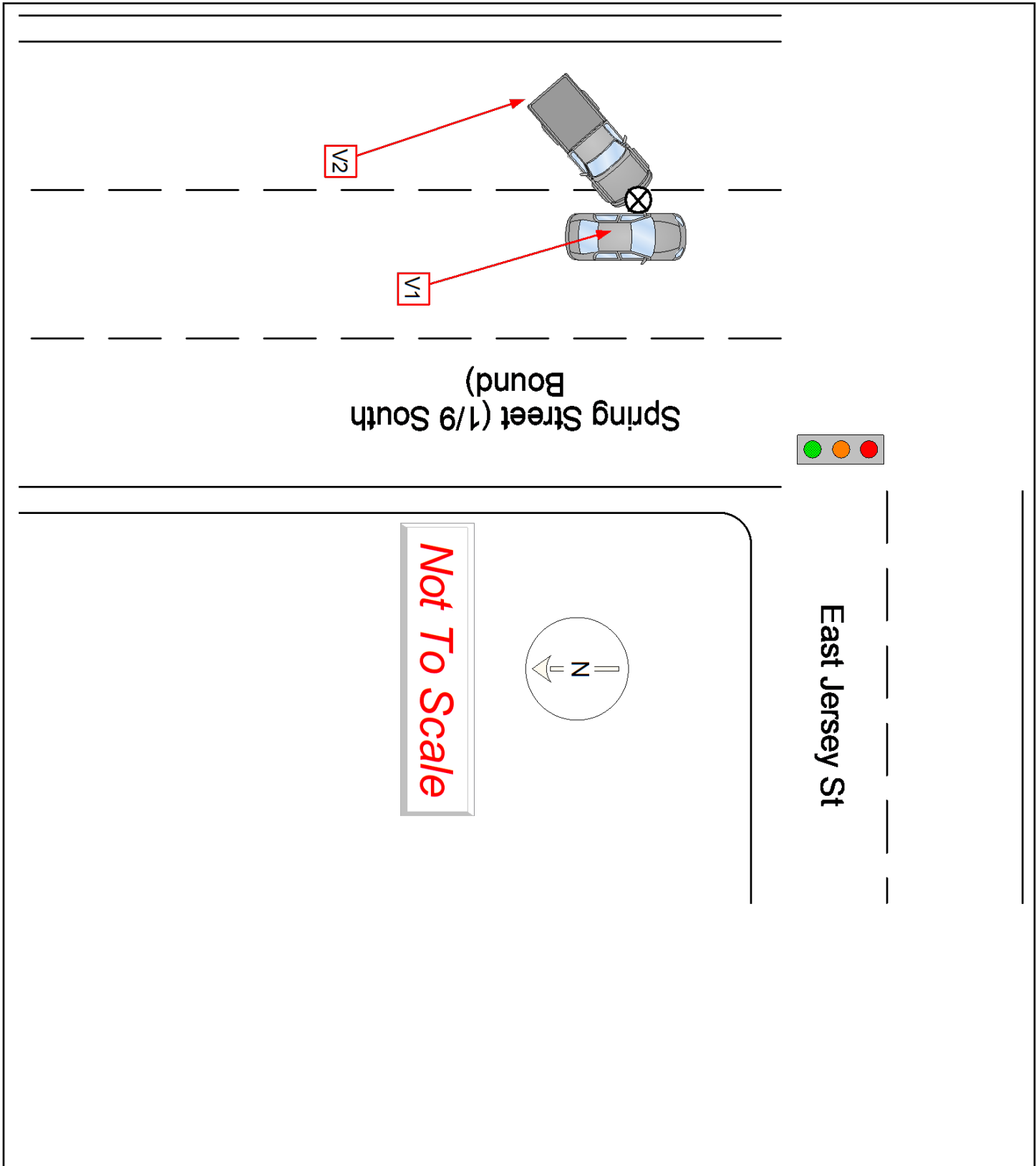
