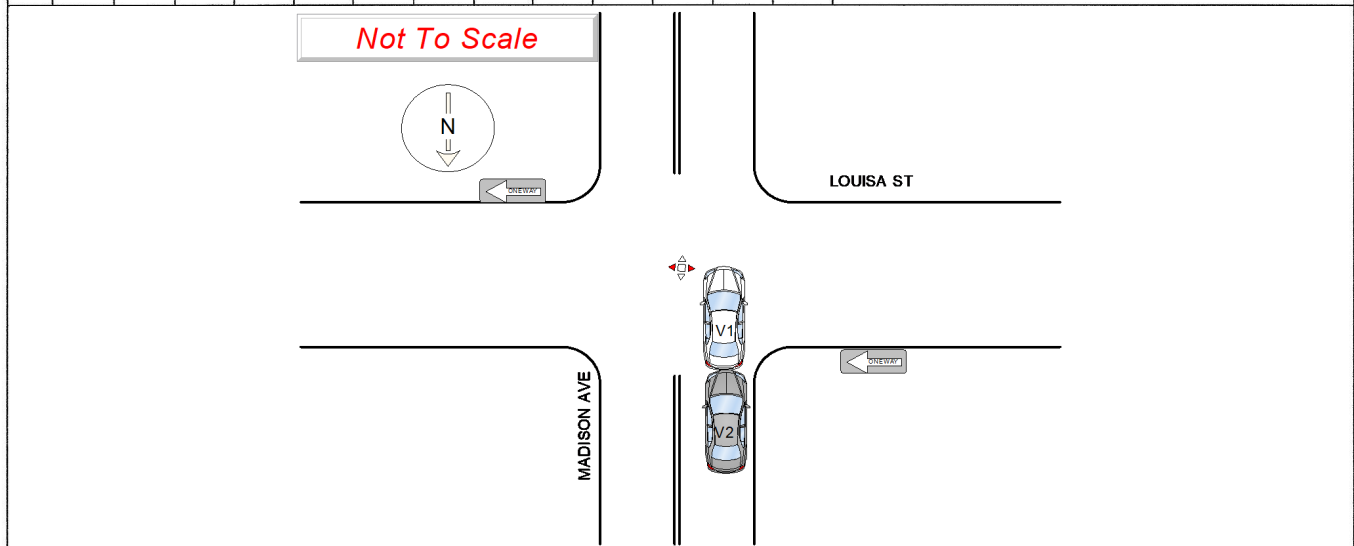

Driver 1 stated she was slowing down for the red light when vehicle 2 struck her from behind. Vehicle 1 sustained minor damage to the rear bumper.

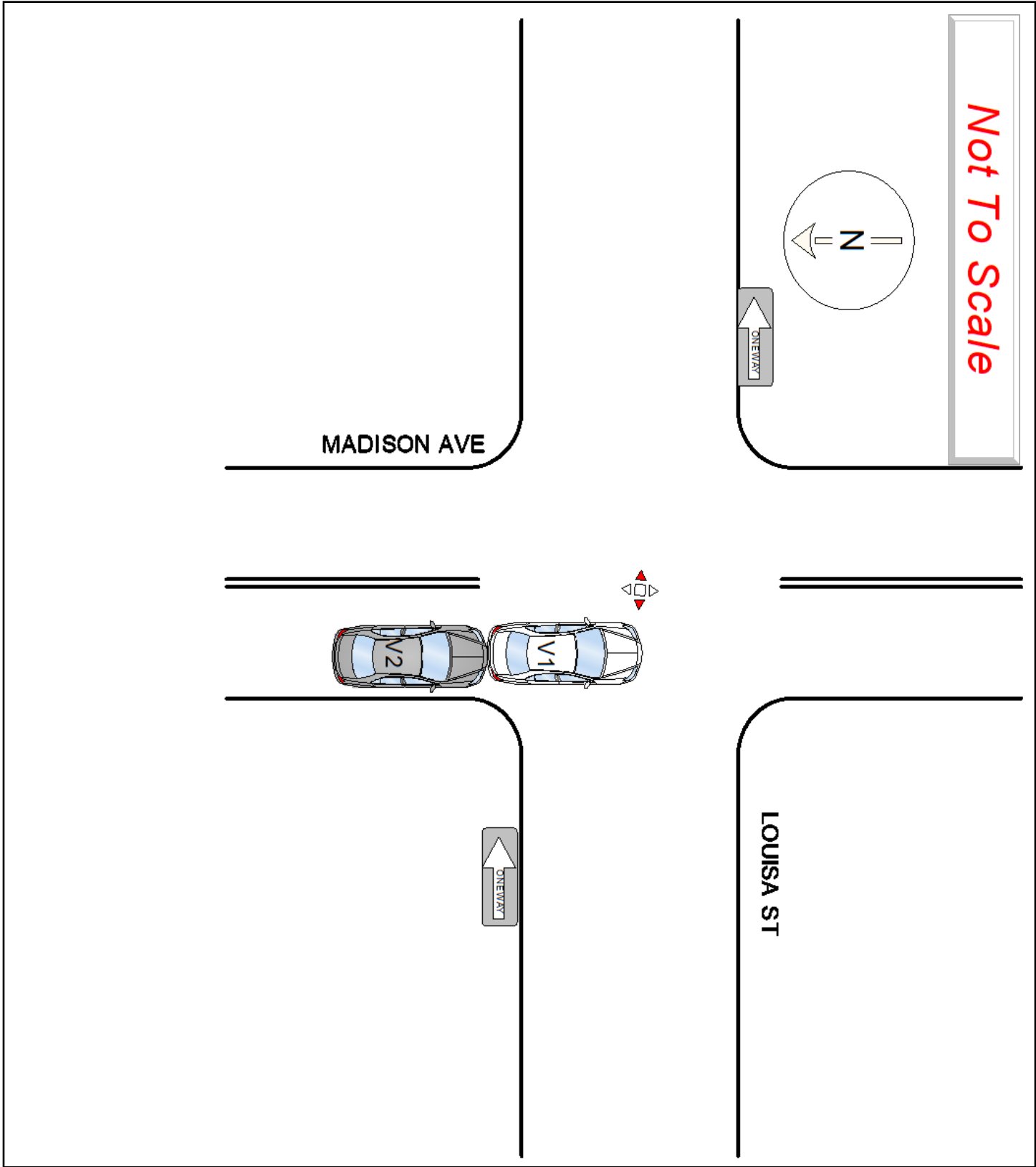
Driver 2 stated the light was green and driver 1 stopped which caused her to strike vehicle 1. Vehicle 2 sustained minor damage to the front bumper.
