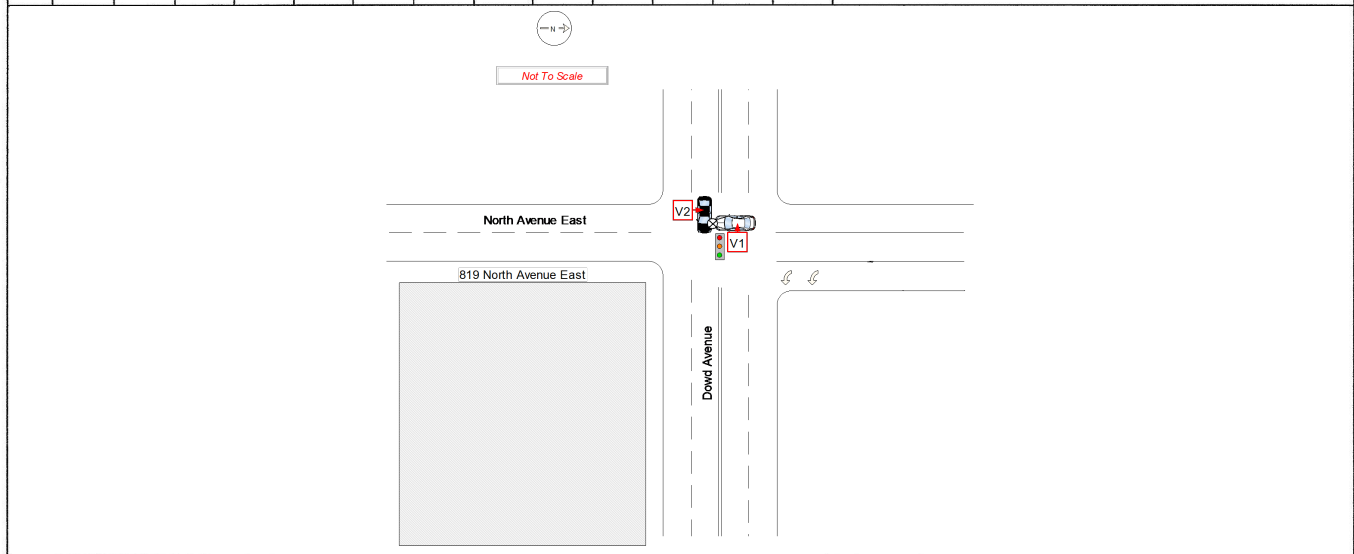

Driver of V1 stated he was driving Westbound on North Ave East, as he approached the intersection he collided with V2. V1 had the right away. There was front end damage to V1.
