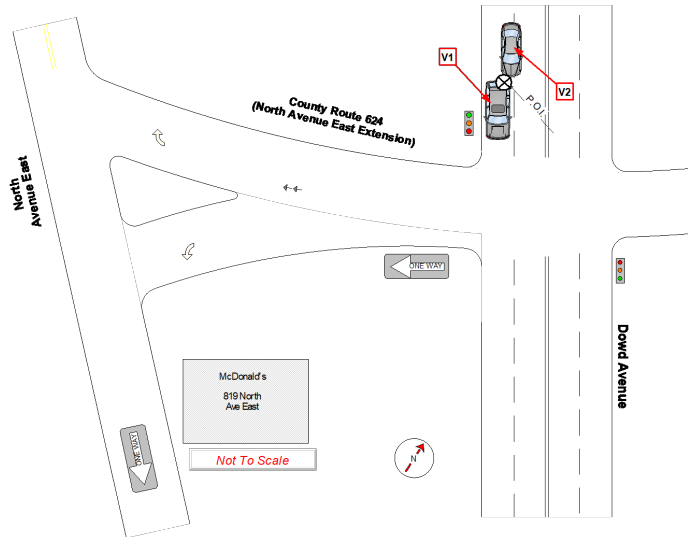

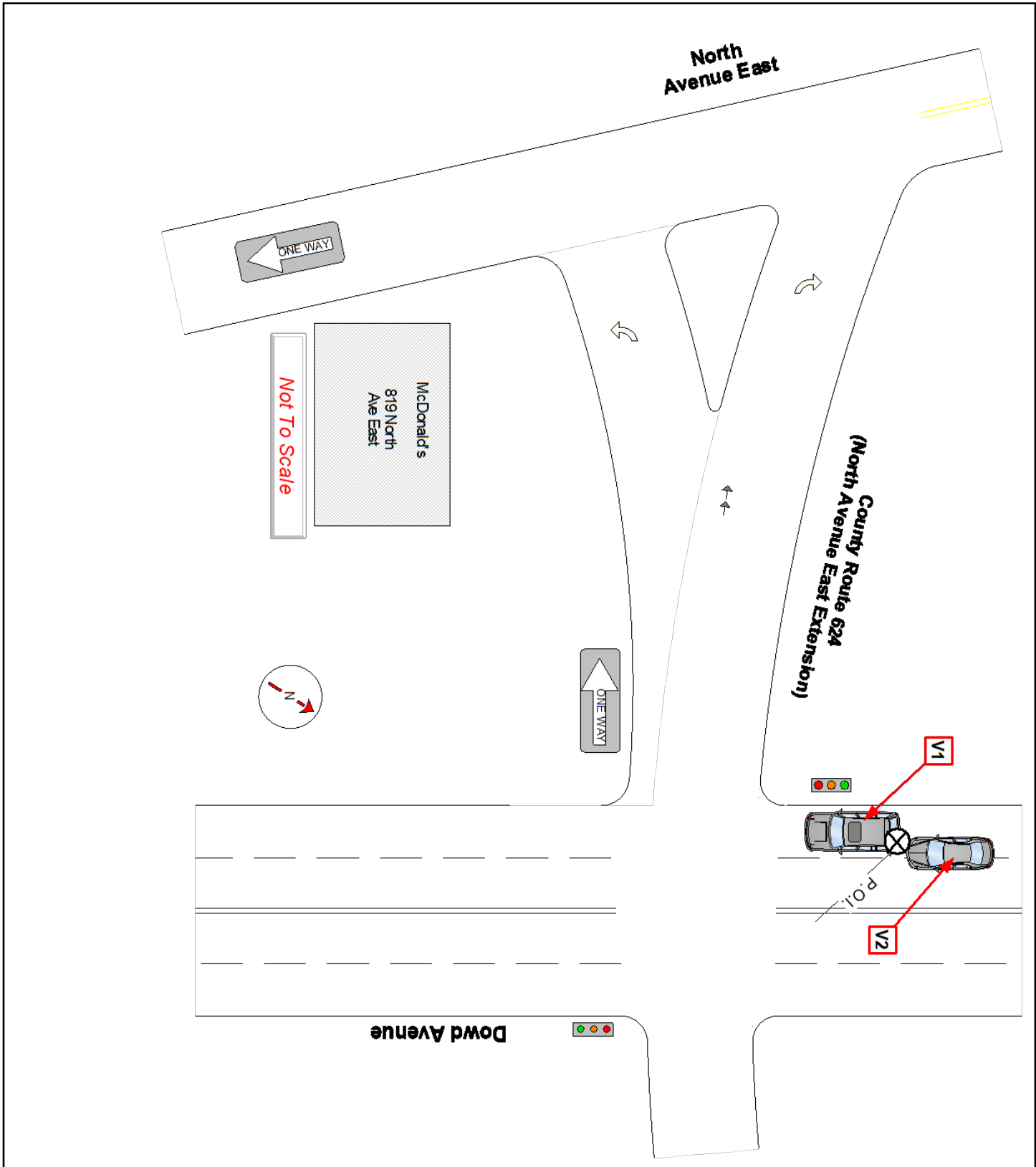
145. Crash Description/Narrative

Driver of vehicle 1 stated she was waiting for the traffic light to change from red to green at the intersection of North Avenue and Dowd Avenue when vehicle 2 struck her back driver side bumper disabling her rear driver side tire. Same stated vehicle 2 did not stop to speak to her and fled the scene South on Dowd Avenue. Driver 1 was able to obtain a photo of vehicle 2 NJ registration (K981 AG) as it was driving. Same stated vehicle 2 had two female occupants driver and passenger but was unable to get a good look of their faces. Driver 1 complained of pain but will be going to the hospital on her own. Passenger of vehicle 1 also did not have any complaints at this time. Parties were advised accordingly. BWR
