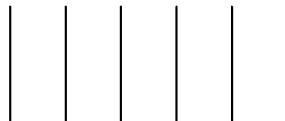
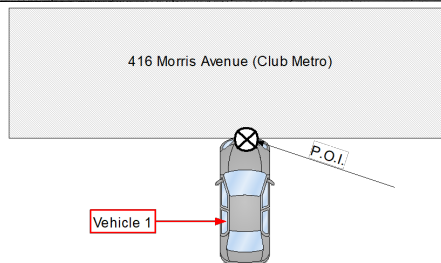

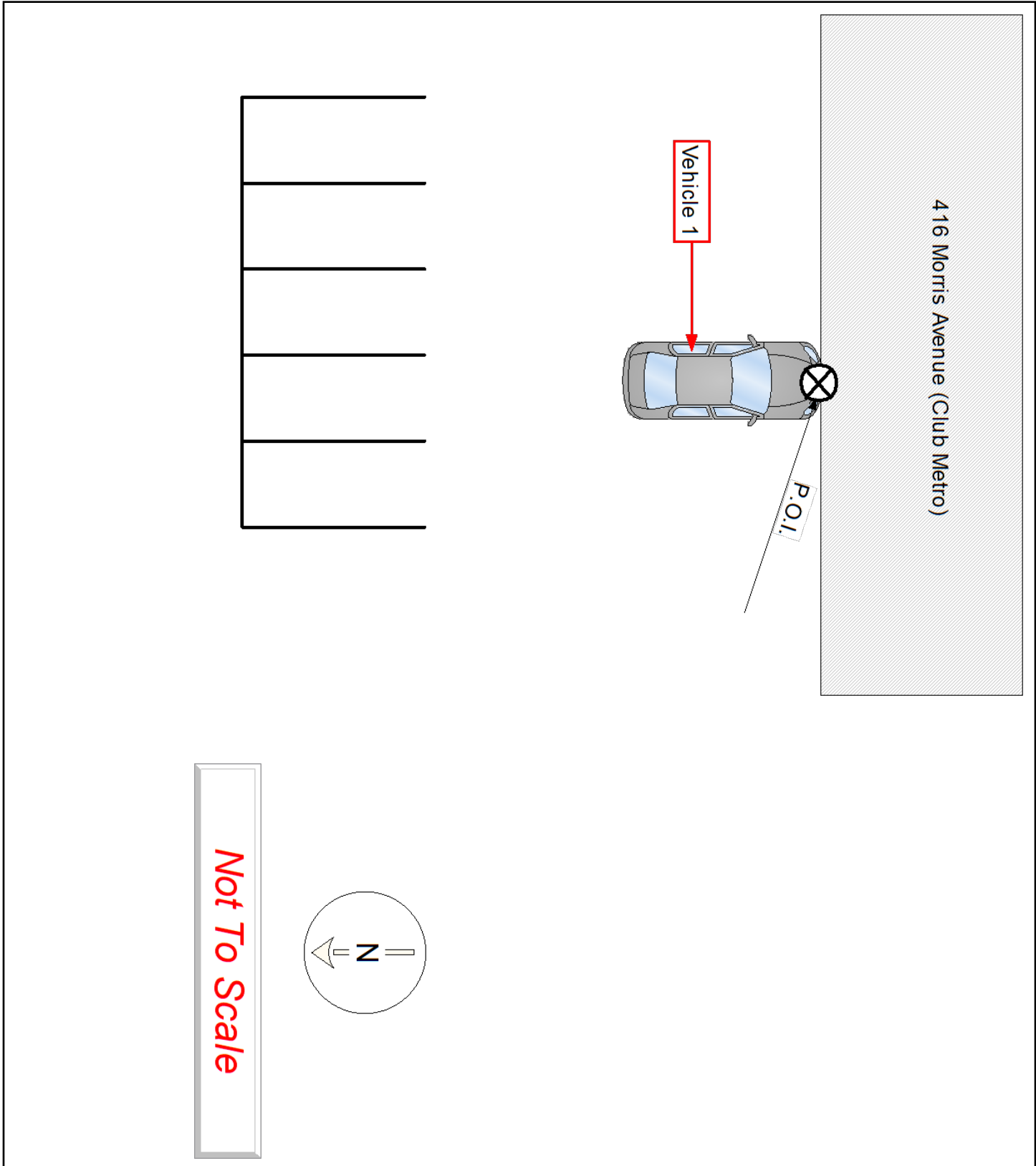
145. Crash Description/Narrative

On Sunday November 24, 2019 I (Officer B. Navas) was dispatched to 416 Morris Avenue (Club Metro) for an accident report. Upon arrival I met with an employee, Yarielis Ramos, who stated that the gym was closed this morning at 00:00 hours. Yarielis stated that this morning a customer walked in and stated that the window was cracked and there was visible damage to the interior dry wall. Yarielis then walked outside and observed a NJ license plate bearing Y97JAL on the floor right in front of the damaged window. I took custody of the license plate and tagged it as evidence under this case number. Yarielis was advised accordingly.
