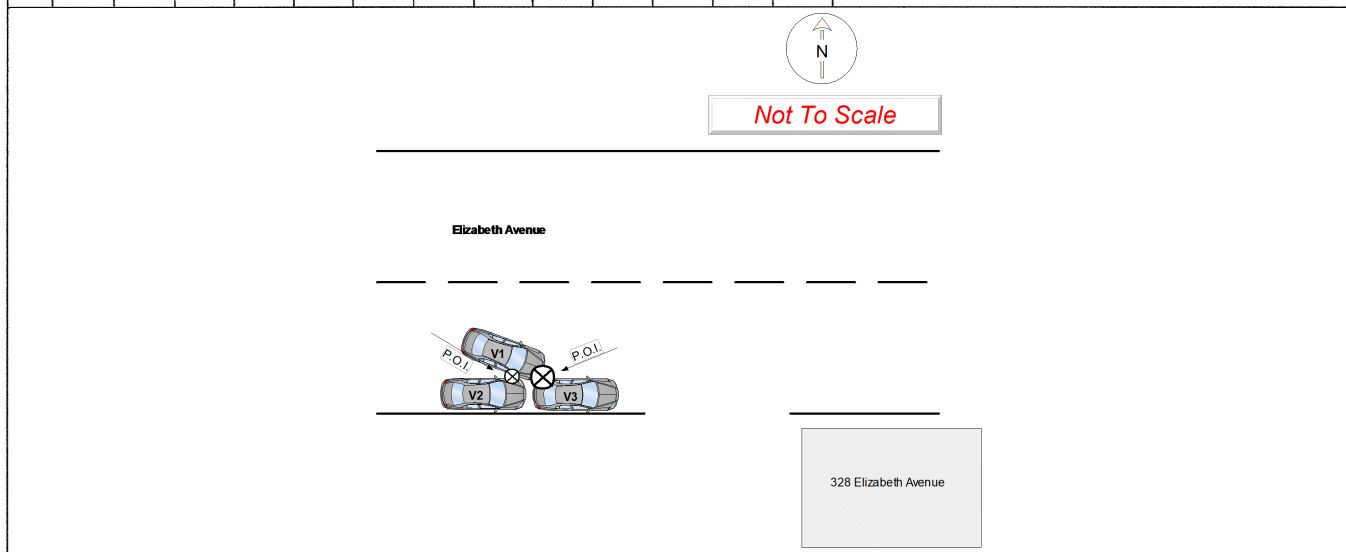

145. Crash Description/Narrative

On 11/24/2019 at 02:56 hours PO Ambroise and I (PO Campos) were dispatched to 328 Elizabeth Avenue for a motor vehicle accident. Upon our arrival 7 Power (Gonzalez/Pereira) were on scene gathering information. 7 Power spoke with a witness, Carlos Castelon, who stated that he observed vehicle 1, FL plate: IBW152) driving east on Elizabeth Avenue. Vehicle 1 then crashed into vehicle 2 (X77FHH) and vehicle 3 (SXG61N). A hispanic male wearing a white jacket then exited vehicle 1 and fled the scene east on Elizabeth Avenue.

Moments of vehicle 1, Ivonne Gutierrez, contacted Elizabeth Police dispatch and advised them that her vehicle had been stolen from 1039 Williams Street and did not have any knowledge to who might have taken in. Refer to report # See page 2

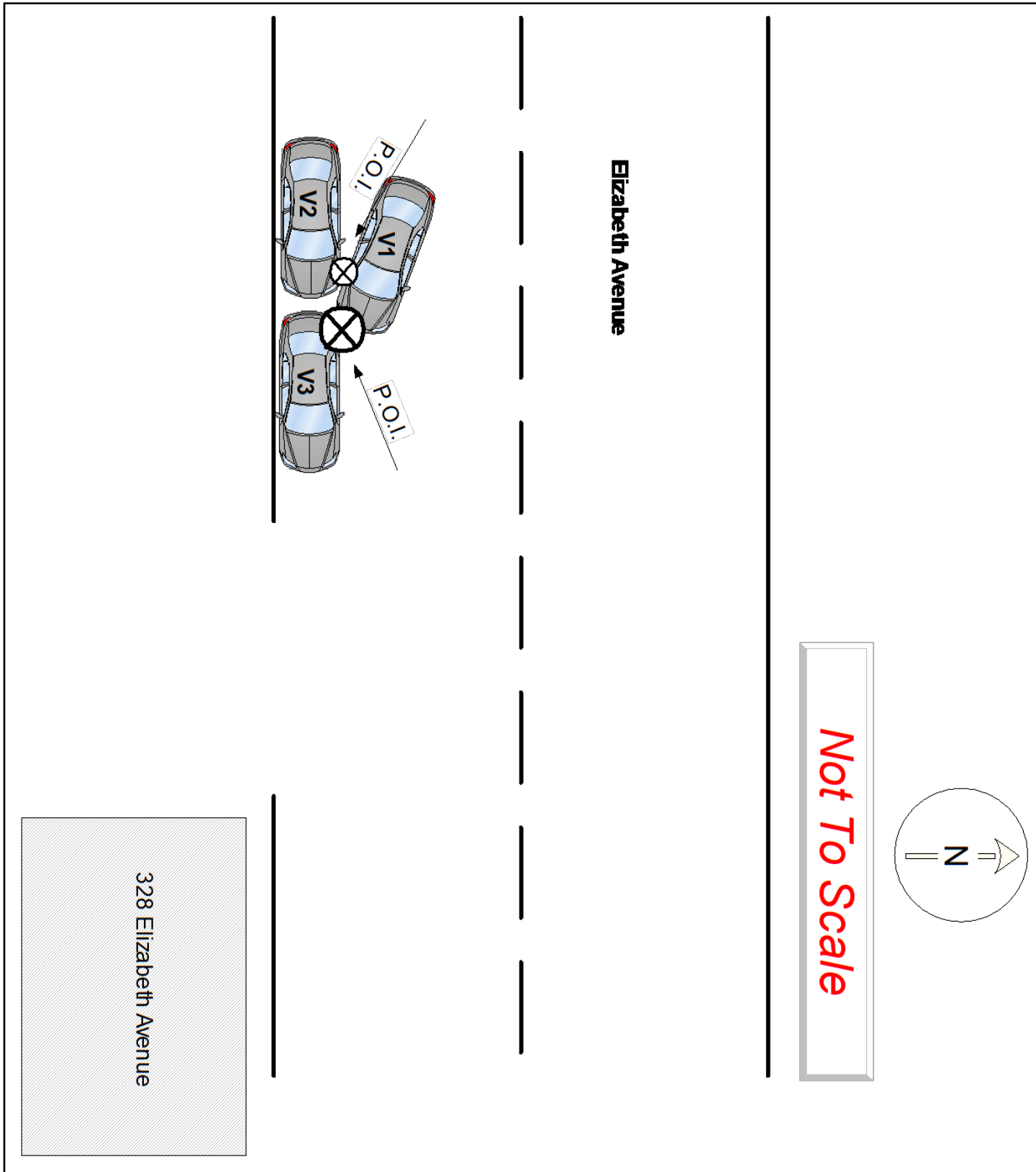
