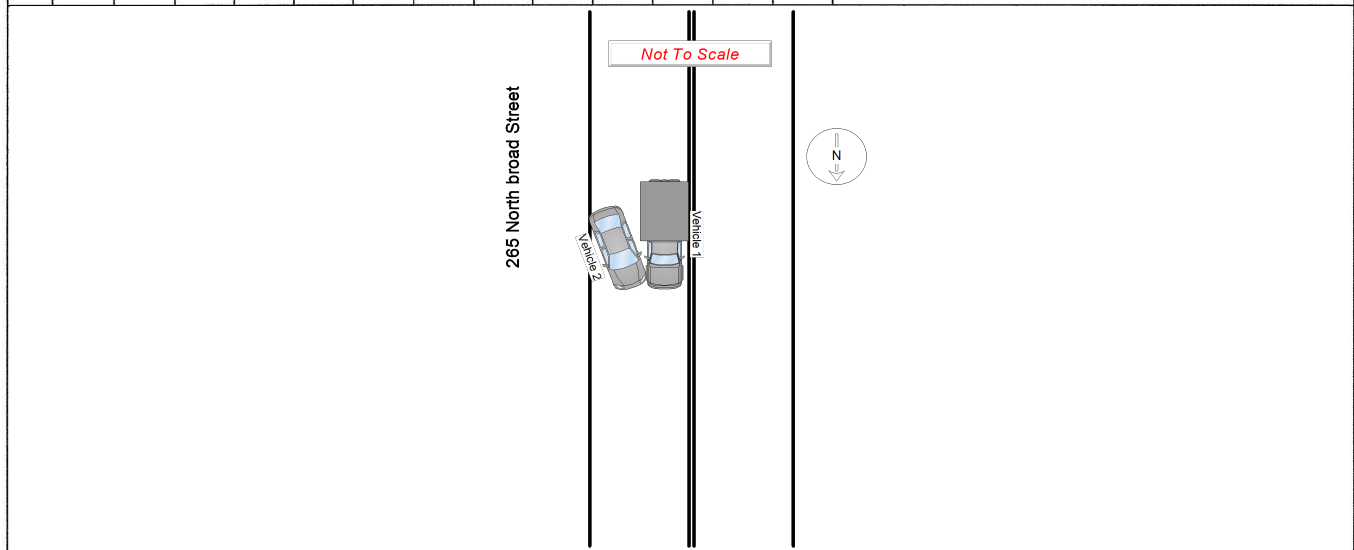

145. Crash Description/Narrative

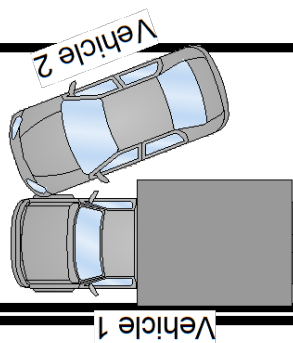
Driver 1 reports that he was traveling North on North Broad Street when vehicle 2 pulled out of a parking spot into his vehicle.

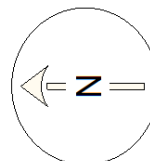
