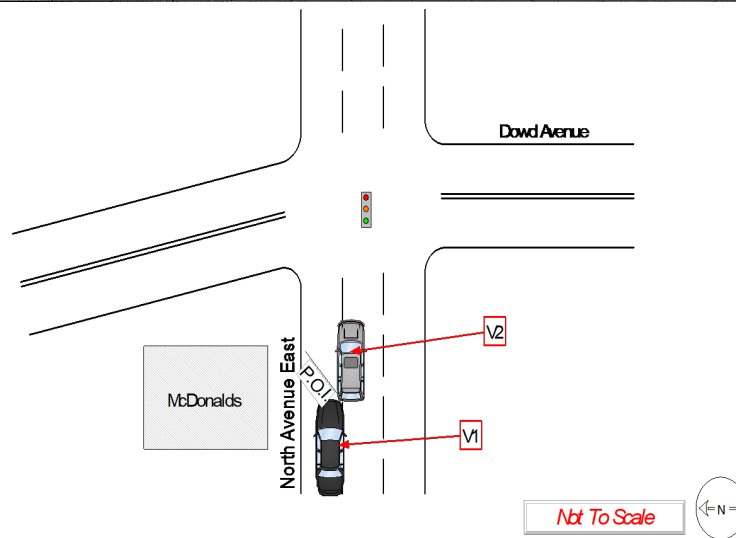

145. Crash Description/Narrative

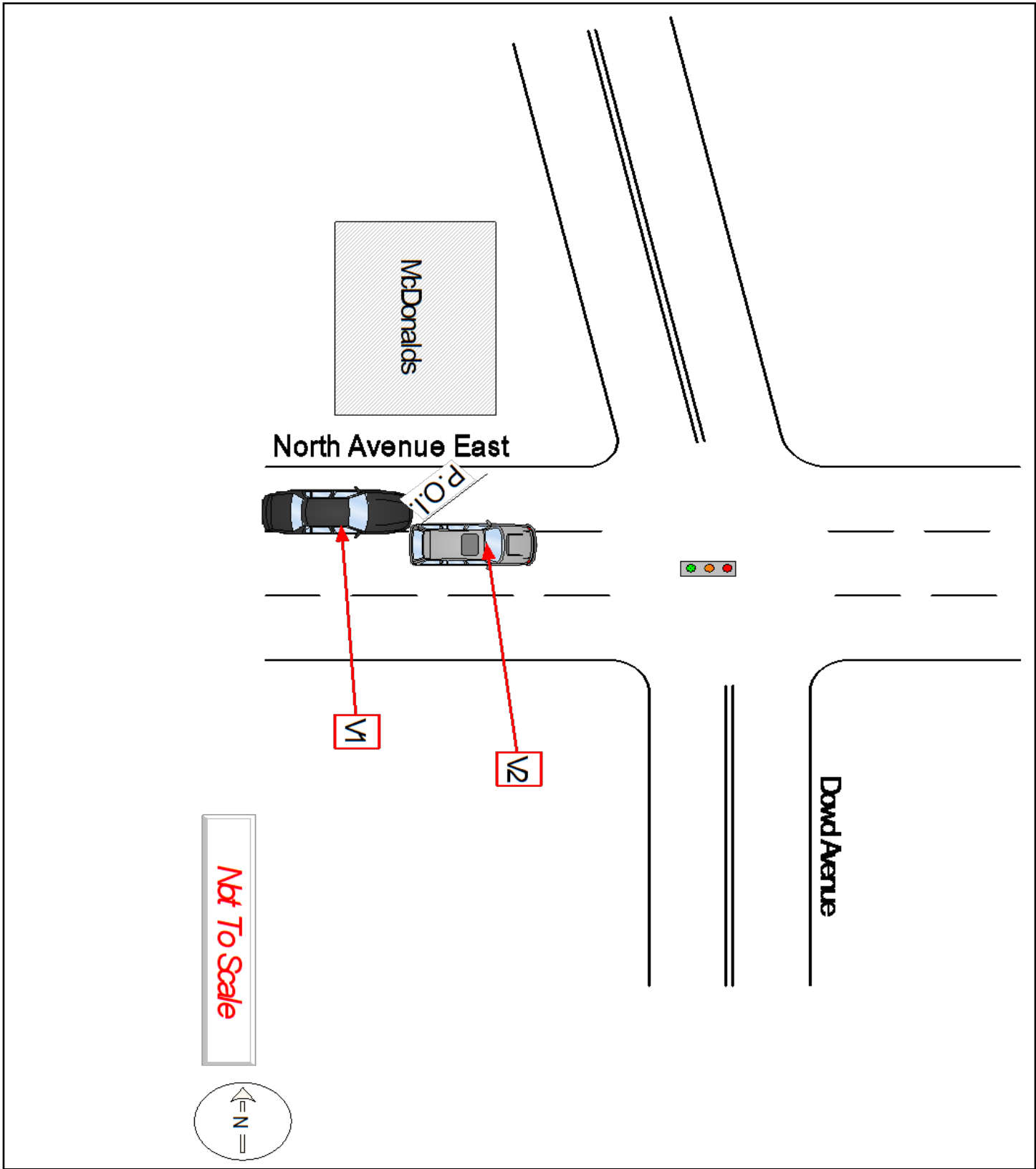
Driver of vehicle 1 stated that while stopped in traffic, she collided with vehicle 2. Driver 1 stated that she did not observe the distance between her vehicle and vehicle 2 and struck vehicle 2 on the driver side rear bumper. Vehicle 1 sustained damage to the front passenger side bumper. Driver 1 was issued a summons (2004 F19 042436) for driving with an expired drivers license.

Driver of vehicle 2 stated that she was struck by vehicle 1 while stopped in traffic. Her vehicle sustained damage to the rear driver side bumper.

Parties were offered but refused medical attention. Parties were advised accordingly. BWR
