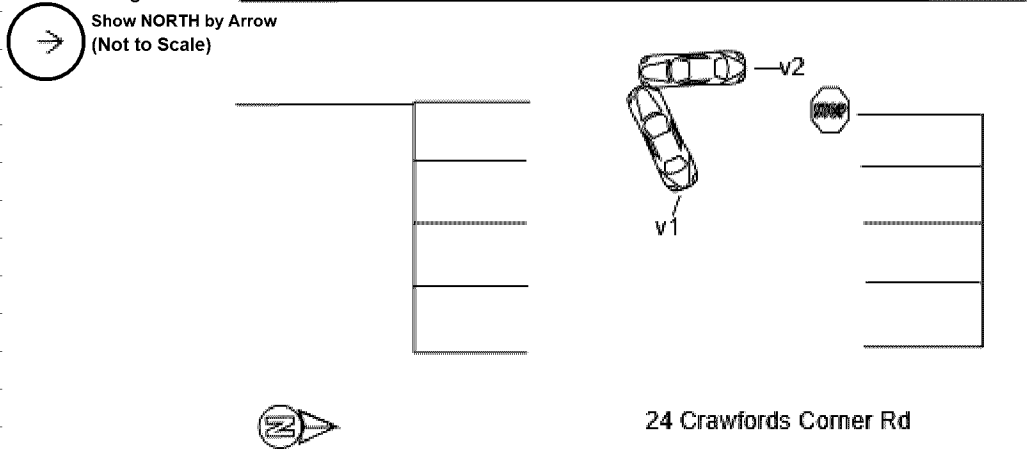

145. Crash Description/Narrative

Investigation of the scene revealed that V1 crashed into V2. The operator of V2 stated that V1 crashed into her and then drove off from the scene after attempting to get her attention. The operator of V2 stated that she followed V1 to Red Hill Rd where they exchanged words. The operator of V1 stated that she was unaware that she struck V2 and continued driving home thinking that V2 was just an angry driver. Surveillance cameras from the Satz School showed V1 going through the stop sign and crashing into V2. After the crash V1 was seen exiting the school property with V2 following.
