145. Crash Description/Narrative

The Driver of Veh #2 was operating a marked Police Vehicle, with it's overhead emergency lights activated. He had just completed making a U-Turn from Rt 70 Eastbound to Rt 70 Westbound, when he was struck by Veh #1.

The Driver of Veh #1 was traveling Westbound on Rt 70 and struck Veh #2. The Driver of Veh #1 stated that he had observed Veh #2 activate his overhead emergency lights, but did not see the vehicle when he struck it.

Driver #1 was found to be at fault for Driver Innattention and Failure to Yield to an Emergency Vehicle.

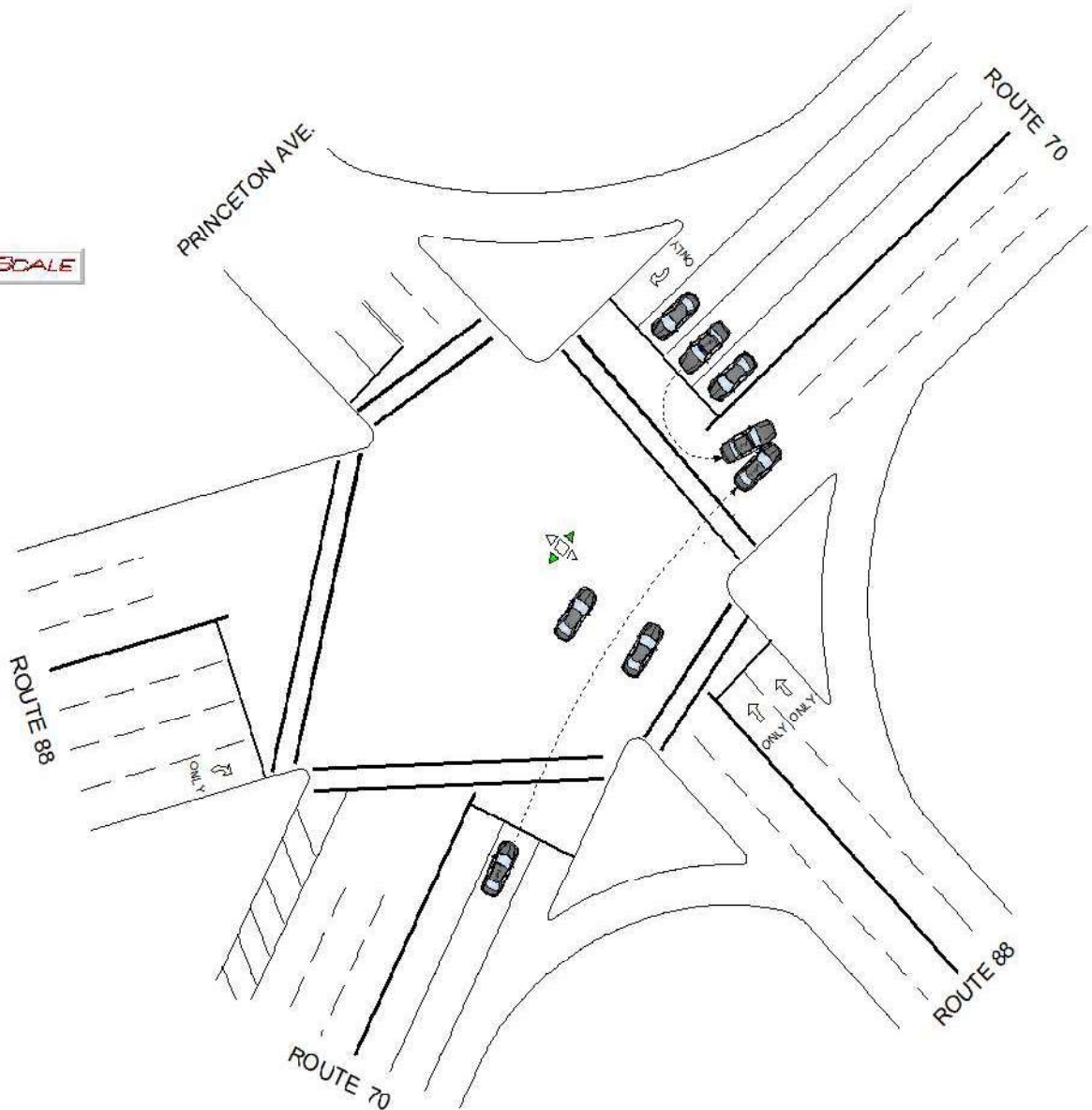
