

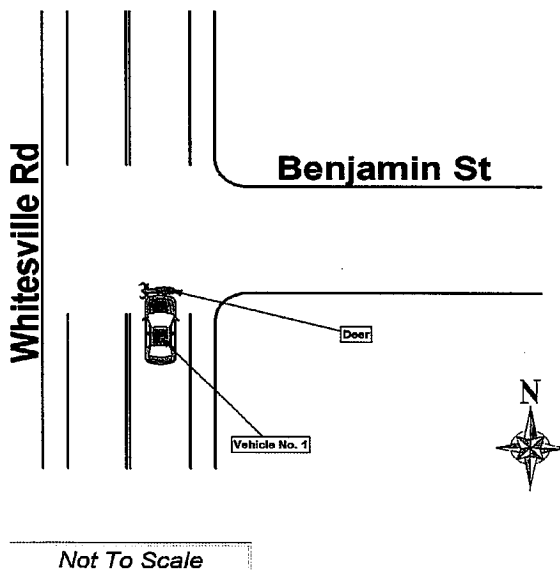

145 Crash Description/Narrative

V1 was travelling northbound on Whitesville Rd, approaching Benjamin St. Upon entering the intersection of Whitesville Rd and Benjamin St, a deer entered the roadway, travelling westbound. D1 advised that he attempted to avoid impact with the deer, however he could not. As a result, V1 impacted the deer. This caused damage to V1, and made it disabled.

D1 did not have any complaint of pain and refused medical attention.
