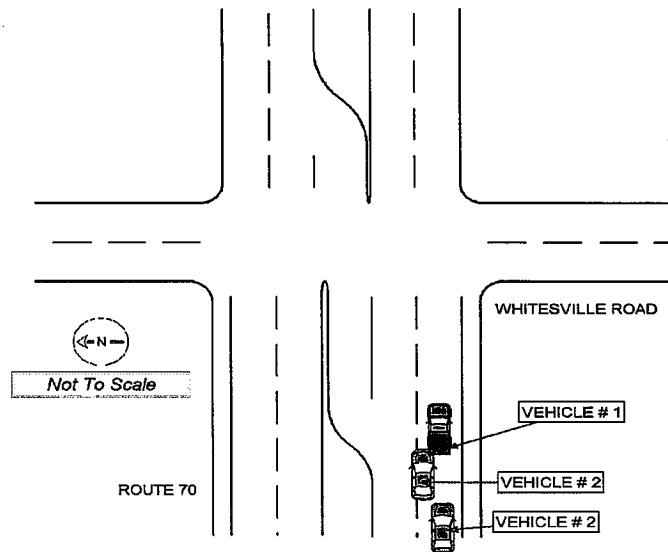

145 Crash Description/Narrative

Vehicle # 1 was stopped (in the right lane) in traffic at a red light (facing East) on Route 70 (approximately 100 feet West of Route 70 / Whitesville Road intersection.) Vehicle # 2 was traveling East on Route 70, and approaching Route 70 / Whitesville Road intersection) As Vehicle # 2 was traveling East in the right lane (and approaching Vehicle # 1 from behind) it attempted to switch lanes (from right lane to the left lane,) but could not due to being "cut off" by another vehicle. As Vehicle # 2 was approaching Vehicle # 1, it failed to stop and struck Vehicle # 1. Vehicle # 2's front passenger's side hood/fender area struck Vehicle # 1's rear driver's side fender, causing minor damage. Driver "1 stated " I was stopped at the red light and he just smacked right into the back of me." Driver # 2 stated "I tried stopping but I couldn't and I hit him." All parties involved stated they do not have any injuries and refused any medical attention at this time. Accurate Towing Company responded and took custody of Vehicle # 2 .

Driver # 2 was issued e-ticket summons # E17-010575 for 39:3-29A.
