145. Crash Description/Narrative

Vehicle 1 was exiting the parking lot of Camp Mall, going west. Vehicle 2 was traveling east on Route 88. When vehicle 1 was entering the roadway, it struck the front of vehicle 2. Due to the accident, both vehicles sustained major damage disabling both, with air bag deployment.

The driver and passenger of vehicle 1 sustained minor injuries and were transported to Ocean Medical Center for further evaluation. The driver and passenger of vehicle 2 were evaluated on scene, but refused medical attention.

The driver of vehicle 1 stated, "I looked both ways, but didn't see any vehicles coming, so I started entering the road. At the last minute I saw the car coming, but couldn't avoid the accident."

The driver of vehicle 2 stated, "I was driving down Route 88, when the car just pulled out in front of me and I crashed into it."

Upon completion of my investigation, vehicle 1 was to be found at fault.

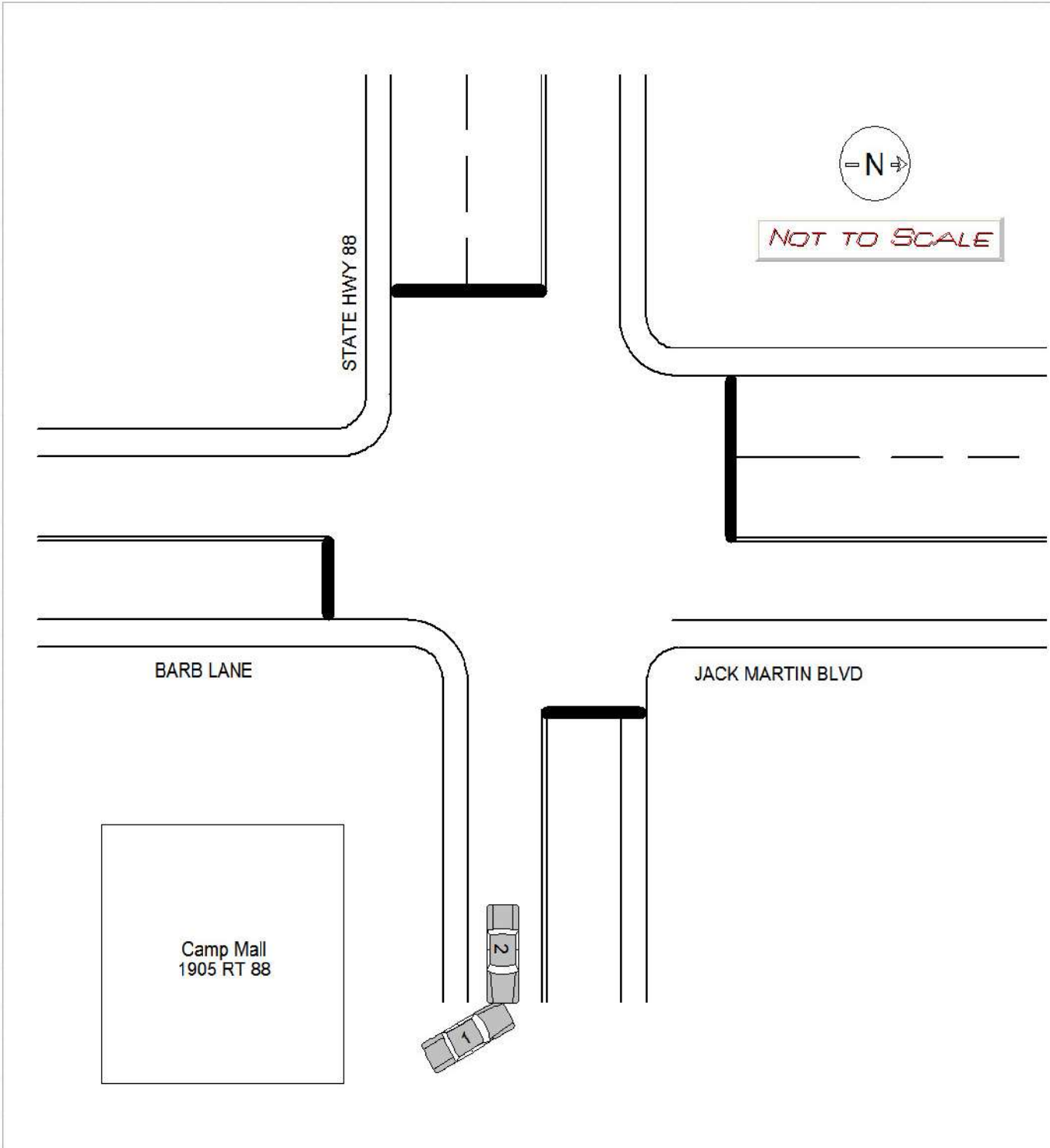
