145. Crash Description/Narrative

Vehicle 1 and Vehicle 2 were both traveling straight on Rt 88 West approaching the traffic light for Olden St.

Both vehicles turned right onto Olden St at the same time and vehicle 1 collided with vehicle 2.

There were no reported injuries at the scene and minor damage was observed to both vehicles.

The driver of vehicle 1 stated she was traveling straight on Rt 88 West approaching the traffic light for Olden St. She observed vehicle 2 ahead of her with the left turn signal on, as she began to turn right onto Olden St vehicle 2 suddenly turned right and she had no time to avoid the collision and collided with vehicle 2.

The driver of vehicle 2 stated he was traveling straight on Rt 88 approaching the traffic light for Olden St. He began to turn right onto Olden St, when vehicle 1 also turned right and collided with his vehicle.

Due to conflicting statements at the scene it is undetermined who is at fault.

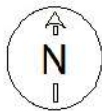

144 Crash Diagram (NOT TO SCALE)

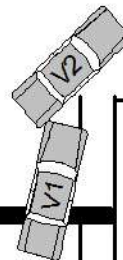


OLDEN STREET
