145. Crash Description/Narrative

Vehicle #2 was stopped in traffic on RT 88 at Younger Street, attempting to make a left turn onto Younger Street.

Vehicle #1 was traveling Eastbound on RT 88, behind Vehicle #2. Vehicle #1's left fender and front bumper struck Vehicle #2's right rear quarter panel and rear bumper.

Driver of Vehicle #1 stated he was traveling Eastbound on RT 88. Driver of Vehicle #1 stated he observed vehicles stopped in the road to make a left turn, into what he believed was the Walmart entrance. Driver of Vehicle #1 stated he attempted to pass vehicles on the right shoulder when he rear ended a vehicle he did not observe until the crash. Driver of Vehicle #1 stated he never saw any of the vehicles in front of him with a left turn signal illuminated.

Driver of Vehicle #2 stated he was stopped in traffic on RT 88 waiting to make a left turn onto Younger Street. Driver of Vehicle #2 stated as he was waiting to make a safe left turn, he was rear ended by a vehicle behind him. Driver of Vehicle #2 stated he makes that left several times a day, and he puts his blinker on several hundred feet prior to the turn. The front seat passenger refused to be transported to Brick Hospital by EMS, but was transported by a family member while I was still on scene. Driver of Vehicle #2 was given a "Victim involved

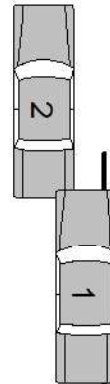
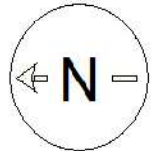
