145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 and #2 were traveling on Rt. 70 (Westbound) in the area of Olden St.

Vehicle #2 began to start in traffic after waiting for the green traffic signal when Vehicle #1 struck Vehicle #2 in the rear.

Driver of Vehicle #1 advised he observed Vehicle #2 begin to start in traffic on Rt. 70 after waiting at the red light. Driver of Vehicle #1 relayed he slowed while Vehicle #2 accelerated and then looked down, taking his eyes off the road. Driver of Vehicle #1 advised he struck the rear of Vehicle #2.

Driver of Vehicle #2 advised he was accelerating on Rt. 70 when his vehicle was struck in the rear by Vehicle #1.

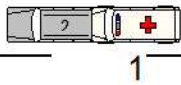
