145. Crash Description/Narrative

Vehicle 1 was traveling westbound on State Highway 88 approaching the intersection of Post Road. Vehicle 2 was traveling northbound on Post Road, approaching the same intersection. Vehicles 1 and 2 collided in the intersection.

The drivers made the following statements regarding the collision:

The driver of Vehicle 1 stated that he was driving westbound on RT 88 approaching the intersection. He stated he was following another car through the intersection, and without looking at the traffic signal controlling the intersection, he proceeded through it and collided with the rear passenger door of Vehicle 2.

The driver of Vehicle 2 stated that she had a green traffic signal, and was proceeding straight through the intersection into the parking lot of the First Baptist Church. She observed Vehicle 1 approaching the intersection at a high rate of speed, and in an effort to avoid the collision, accelerated to get out of the way. However, she was unable to avoid the collision and was struck by the front of Vehicle 1. The driver of Vehicle 2 further stated that there was no other car in front of Vehicle 1 when the signal turned green and they started

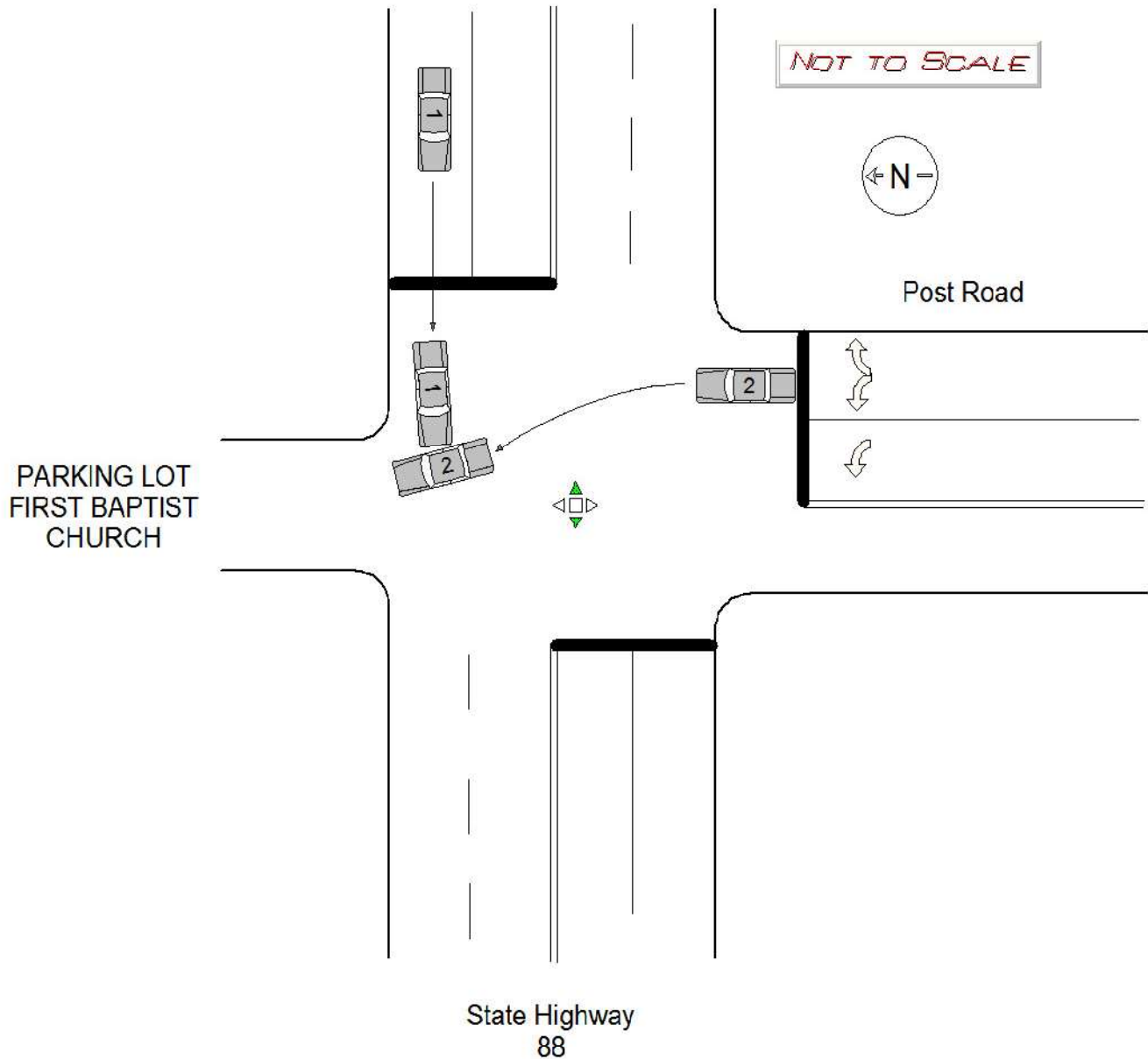
