145. Crash Description/Narrative

Vehicle 1 and 2 were stopped at the traffic signal on Route 88, traveling west. The traffic signal turned green and vehicle 1 accelerated, prior to vehicle 2 accelerating, causing vehicle 1 to crash into vehicle 2.

Neither party had any complaints of pain. Both vehicles 1 and 2 sustained minor damage and were driven from the scene.

Driver of vehicle 1 stated, "It was my fault, I crashed into the back of her."

Driver of vehicle 2 stated, "Once the light turned green, I felt the vehicle crash into my car."

Upon completion of my investigation, vehicle 1 was to be found at fault.

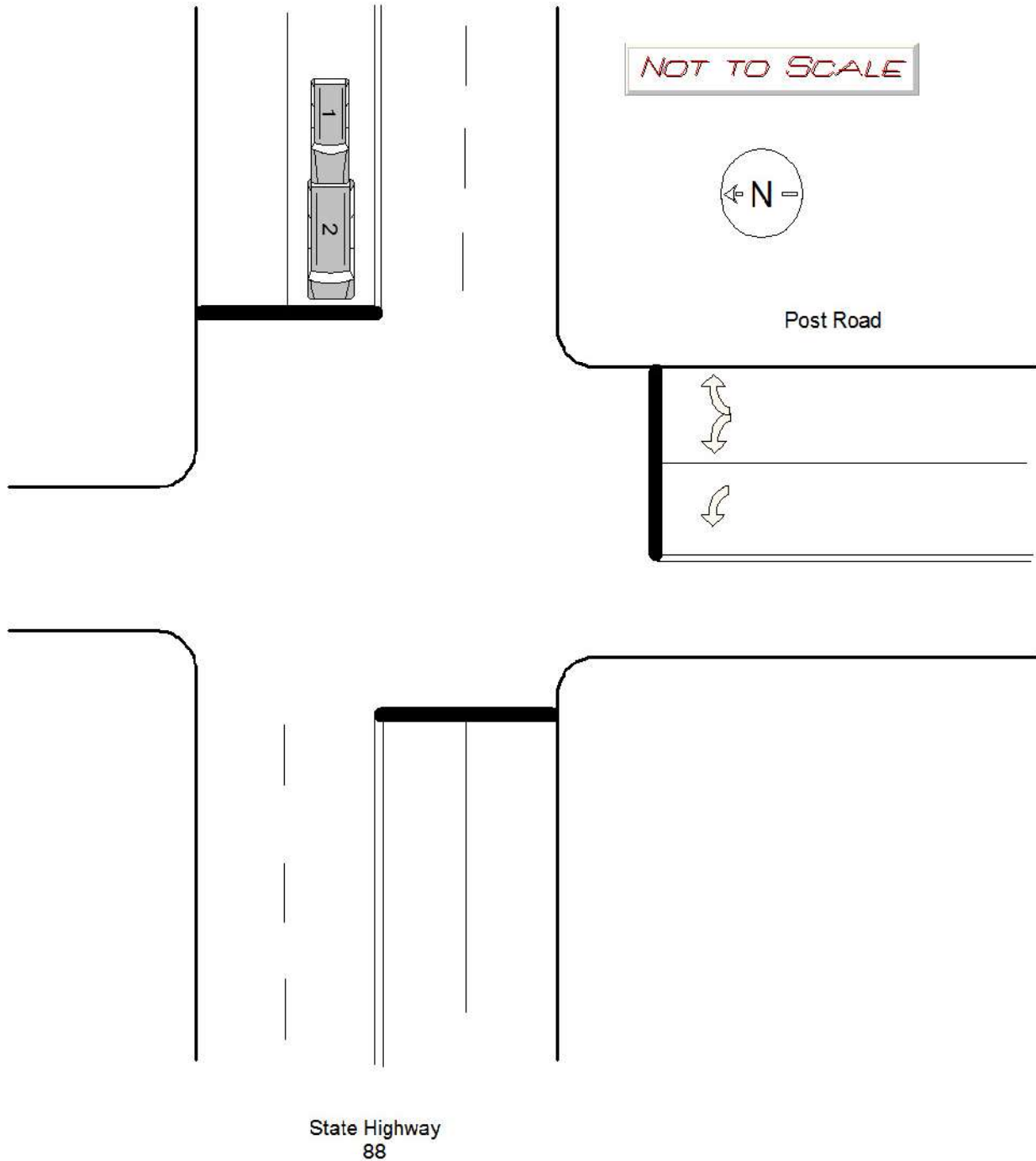
