145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 made a left turn onto Route 70 west from the Route 70 east/Olden Street jug handle. Vehicle 2 made a right turn onto Route 70 west from Olden Street. When both vehicles turned, the middle passenger side of vehicle 1 and the front driver side of vehicle 2 struck.

I spoke to driver 1 on scene and she stated the following:

She had a green light and made a left turn onto Route 70 west from the jug handle. When she got onto Route 70 west, her vehicle was suddenly struck by another vehicle. The vehicle that hit her came out of no where and she did not know where it came from.

I spoke to driver 2 on scene and he stated the following:

He made a right turn from Olden Street onto Route 70 west because he had a green light. As he turned, a white vehicle came out of no where and began to merge into his lane. The middle passenger side of the vehicle then struck the front driver side of his vehicle.

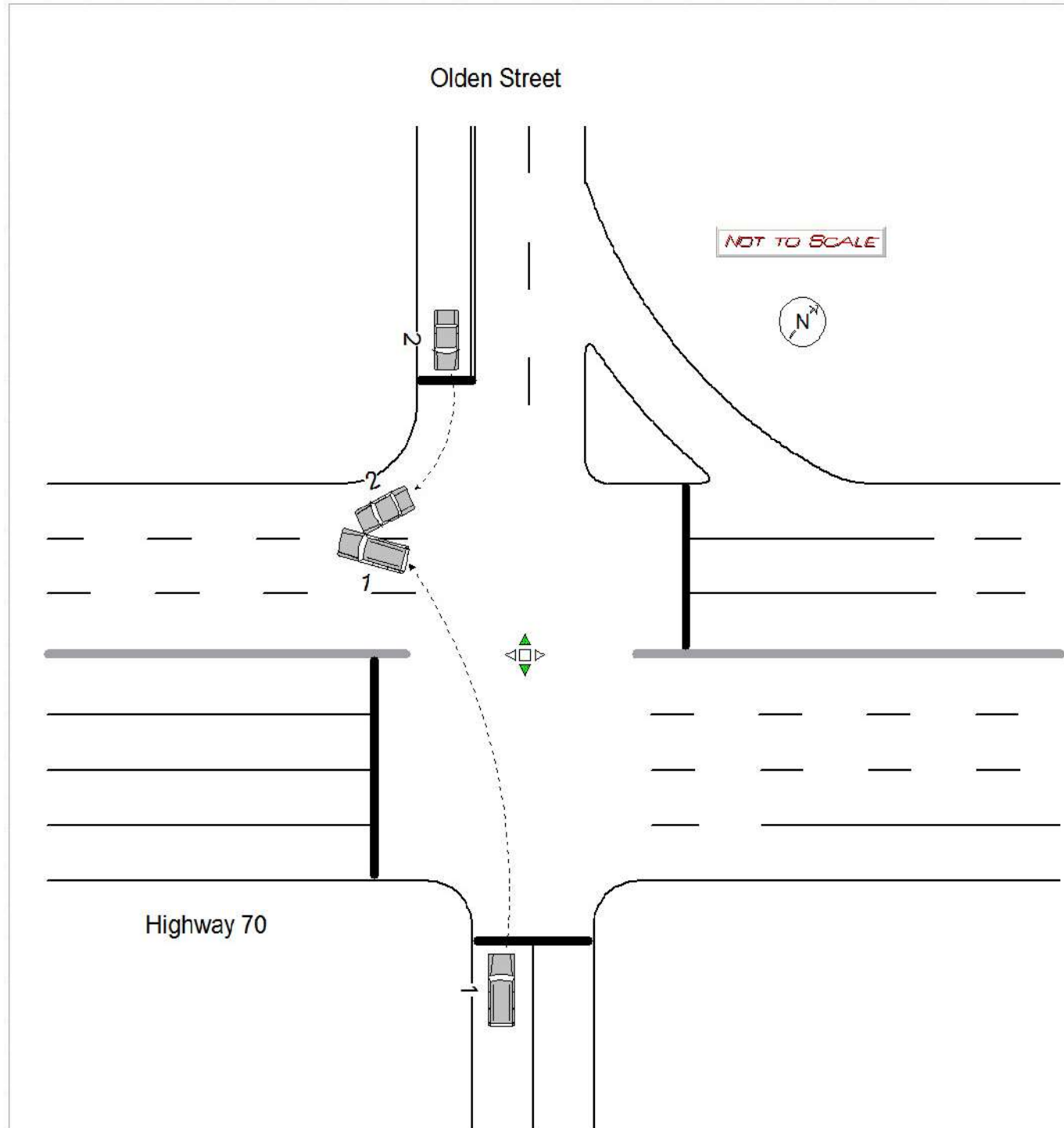
