145. Crash Description/Narrative

Vehicle #2 was backing out of her spot in the Walmart parking lot when she was struck by vehicle #1. Vehicle #2 was out of the spot and was almost turned to face the road when Vehicle #1 backed out of the spot and crashed into the left side of the vehicle.

Driver #2 stated that she had backed out of her parking space and was almost facing the road when she felt Vehicle #1 strike the rear left side of her vehicle. Driver #2 stated that she made sure nobody was coming down the road and that it was clear to back up before she backed out of the space.

Driver #1 stated that he thought it was clear when he started to back out of his parking space. Driver#1 stated that he believes that they exited the parking spaces at the same time and that they both crashed into each other.

Driver #1 does not have a drivers license because he is a citizen of Russia. Driver #1 is in the United States on a work visa.

After conducting my investigation I find that Vehicle #1 is at fault for the incident.

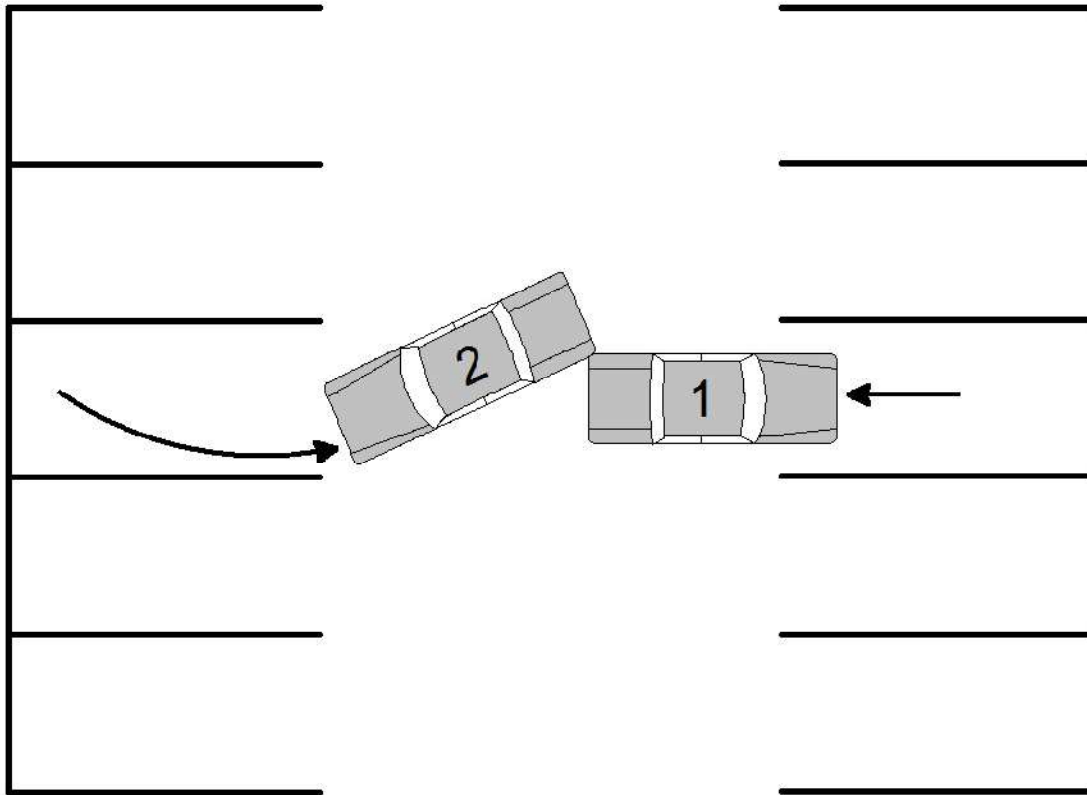
