145. Crash Description/Narrative

Vehicle 1 was traveling south on Jack Martin Boulevard directly behind vehicle 2. When vehicle 2 stopped for traffic to make a left turn onto Frank Neri Drive vehicle 1 rear ended vehicle 2.

Driver 1 stated she was traveling south on Jack Martin Boulevard getting ready to turn right into one of the business parking lots. Driver 1 stated she was not close behind vehicle 2 but she did not notice that vehicle 2 was stopped. Driver 1 stated that by the time she realized vehicle 2 was stopped she did not have time to stop. subsequently rear ending vehicle 2.

Driver 2 stated she was stopped, south on Jack Martin Boulevard with her left turn signal on waiting for traffic, so she could turn onto Frank Neri Drive when vehicle 1 rear ended her.

Investigation revealed that the cause of the crash was due to driver 1 not paying attention to traffic and not observing that vehicle 1 was stopped waiting to turn left.

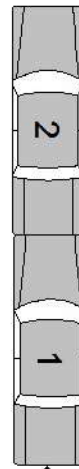
144 Crash Diagram (NOT TO SCALE)
