145. Crash Description/Narrative

Driver 1 stated they were backing out of their parking spot in the parking lot of the Walmart located at 1872

Route 88. Driver 1 stated they had backed out prior to Vehicle 2 and that Vehicle 2 backed out at a high rate of

speed and crashed into them.

Driver 2 stated that they had already backed out of their parking spot when Vehicle 1 began to back out of their

spot. Driver 2 stated that Vehicle 1 had crashed into them.

Based on my investigation and observations of the damage on scene I determined Vehicle 1 to be at fault for the

motor vehicle crash.

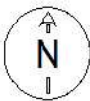

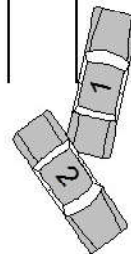
144 Crash Diagram (NOT TO SCALE)
