145. Crash Description/Narrative

The driver of vehicle #2 stated he was on Jack Martin Blvd., in the left lane, stopped at a red light, attempting to turn east on to Rt. 88W, when vehicle #1 struck him from behind.

The driver of vehicle #1 stated she was directly behind vehicle #2. She stated that she was on her cell phone calling her doctor when she struck the rear of vehicle #2.

No injuries reported. No damage to vehicle #2. Moderate damage to vehicle #1.

Based on both drivers statements as well as observing the damage to both vehicles, it is my determination that vehicle #1 caused the crash by using her cell phone and not paying attention to vehicle #2 stopped directly in front of her.

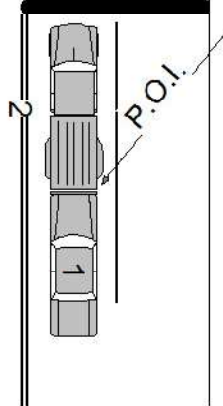
