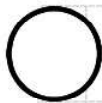

145. Crash Description/Narrative

Vehicle 1 was traveling West on Rt 88 and had just passed the entrance/ exit for Laurel Square Plaza. Vehicle 2 was stopped in traffic on Rt 88 West just passed the entrance /exit for Laurel Square Plaza. Vehicle 1 was unable to stop in time and collided with the rear of vehicle 2.

There was minor damage observed to the front of vehicle 1 and the rear of vehicle 2. the passenger of vehicle 2 complained of head pain but refused medical attention at the scene. There was no other reported injuries at the scene.

The driver of vehicle 1 stated she was traveling straight on Rt 88 West and did not see vehicle 2 stopped and collided with the rear of vehicle 2 . The driver of vehicle 1 was issued a summons for Careless Driving 39:4-97 (T- 152759).

The driver of vehicle 2 stated he was stopped in traffic on Rt 88 West when vehicle 1 collided with the rear of his vehicle.
