145. Crash Description/Narrative

Vehicles 1 and 2 were in the parking lot of the Wawa convenience store located at 595 Brick Boulevard. Vehicle 1 was backing out of a parking spot from in front of the store. Vehicle 2 was traveling through the lot, and had just pulled behind Vehicle 1 to let off a passenger. The driver of Vehicle 1 stated he did not see Vehicle 2 behind him prior to backing out of the spot. Vehicles 1 and 2 then collided in the traveled portion of the parking lot.

No injuries were reported at the scene. No visible damage to Vehicle 1. Cosmetic damage only to the left rear bumper and tail light of Vehicle 2. No summonses were issued. Both vehicles were driven from the scene.

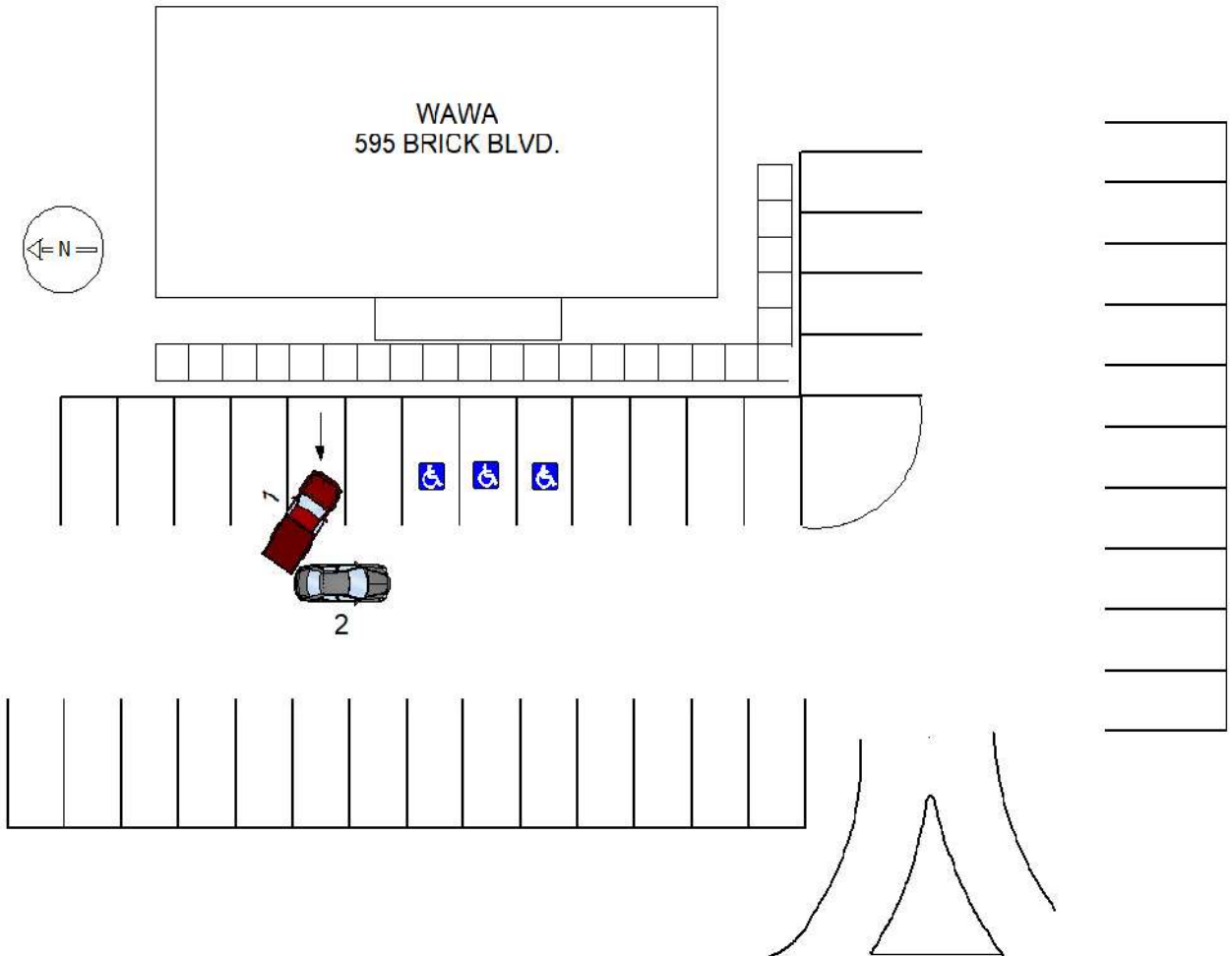
