145. Crash Description/Narrative

Investigation revealed Vehicle #01 was traveling north on Texas Drive. Vehicle #02 was parked on Texas Drive in the area of 374 Texas Drive. Vehicle #02 was parked legally on the right side of the roadway. Vehicle #2 was running with its lights on and had two passengers. The two passengers were identified as Jolene Prendergast (front driver seat) and Christopher Junnes (front passenger seat). Vehicle #01 left its lane of travel and struck the rear of Vehicle #02. Vehicle #01 fled the scene after the crash.

I spoke with Prendergast on scene. Prendergast stated she was driving Junnes around and decided to pull over to use the Internet. She stated she parked her vehicle on the right side of the road with the car still running and lights on. Prendergast stated while they were hanging out, Vehicle #01 crashed into the rear of her vehicle. Prendergast could only describe the suspect vehicle as being white or tan colored. She stated after her vehicle was struck, vehicle #1 fled the area.

A check of the area for Vehicle #01 initially had negative results. Dispatch also advised patrol units that a white colored vehicle in the area of this crash ran over someone's front lawn.

145 Crash Description

Patrolman Taylor #302 subsequently pulled over a white Mazda M6 (New Jersey Registration N60GHE) a short time later after the crash. This vehicle had extensive front end damage, consistent with crashing into the rear of a parked vehicle. The driver of this vehicle was identified as Keith Parker, whom Patrolman Taylor arrested for driving under the influence. See his report under case #32705-21 for more details.

Under case #32715-21 Patrolman Zurica #242 had a "hit and run" crash report. Patrolman Zurica's crash report occurred in the same neighborhood where Prendergast's vehicle was struck. Patrolman Zurica also found debris left at the scene from the suspect vehicle, which happened to be from a white Mazda. See his report for more details.

I spoke with Keith Parker while he was at Brick Police Headquarters being processed. Parker denied crashing into Vehicle #02. Parker stated his vehicle was damaged because he was side swiped.

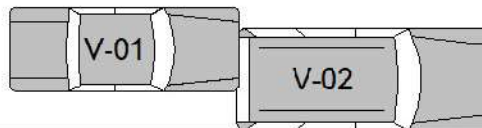
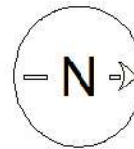
