145. Crash Description/Narrative

Vehicle #2 was parked on the side of the road of Spruce Drive northbound, across from the residence of 338 Spruce Drive. Vehicle #1 was traveling on Spruce Drive northbound, near the residence of 338 Spruce Drive. Vehicle #1's right front bumper struck the left rear fender and wheel of vehicle #2. There was white paint transfer left behind on vehicle #2 from vehicle #1. The resident at 336 Spruce Drive was able to capture the crash on his Nest security camera (See attached video). From his laptop I was able to observe a white sedan traveling northbound on Spruce Drive at approximately 0308 hours. The vehicle traveled past the residence and crashed into vehicle #2. Due to the loud squeals and thumping coming from vehicle #1, it is believed that vehicle #1 had already been involved in a prior accident. It is believed that the vehicle is a white 2011 Mazda 6 NJ Reg. N60GHE that was involved in other "Hit and Run" crashes in the area (See Ptl. Alexander's report - Case# 32697-21, Ptl. Zurica's report - Case# 32715-21, Ptl. Stephenson's report - Case# 32758-21). That vehicle was later stopped by Ptl. Taylor #302 on Cedar Bridge Ave with extensive damage to the right front of the vehicle, reference his case report (Case #32705-21).

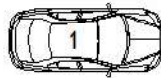
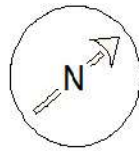
