145. Crash Description/Narrative

Vehicle 1 was traveling south on Schindler Drive in the area of Schindler Drive. Vehicles 2 and three were legally parked in designated parking spots along Schindler Drive. Vehicle 1 struck Vehicle 2 which pushed Vehicle into Vehicle 3. Vehicle 1 then left the scene, leaving behind part of its bumper.

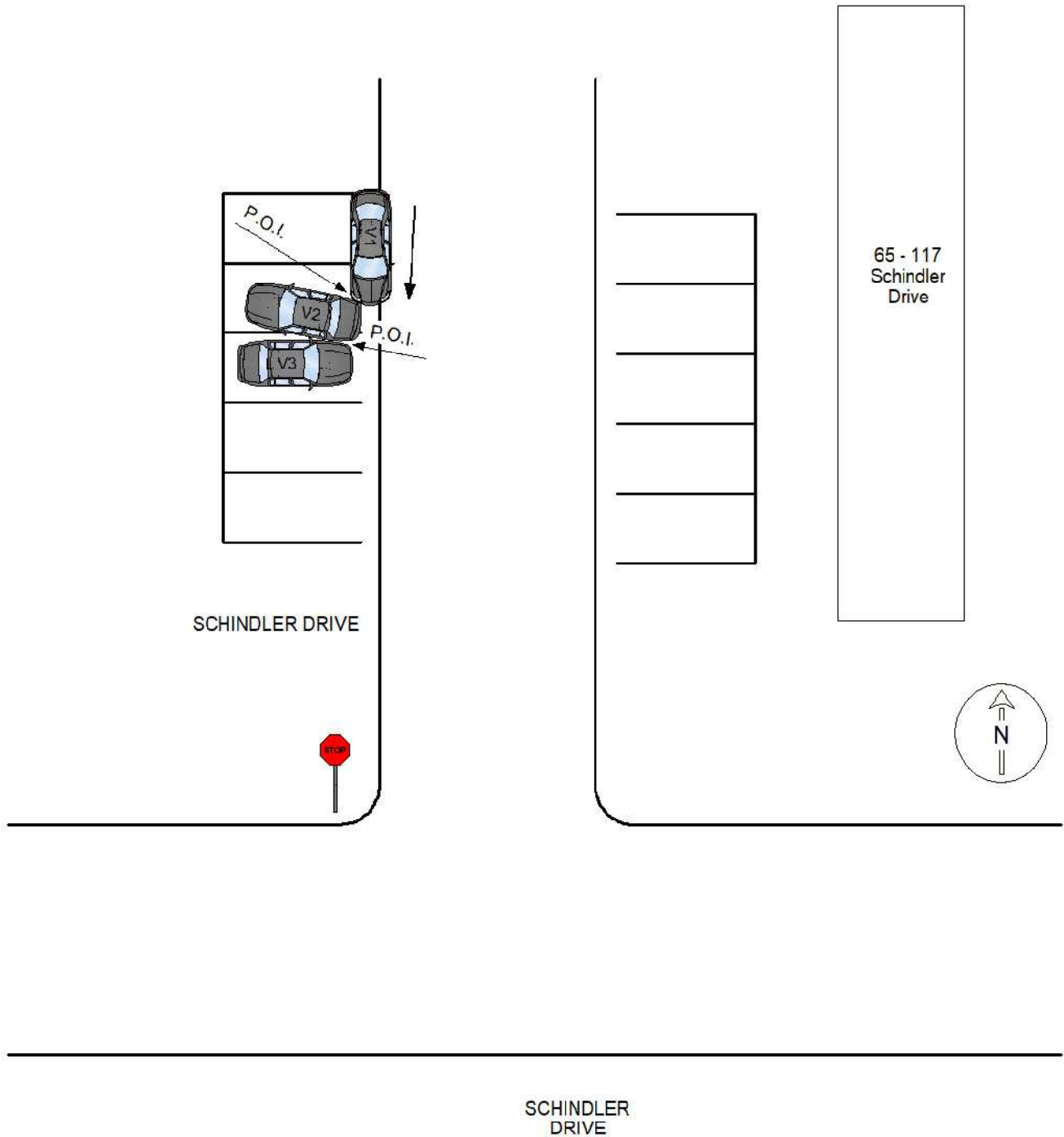
