145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 was traveling on Aschby Rd. attempting to make a left turn on Birch Dr. During the turn Vehicle #1 struck the curb causing Vehicle #1 to roll over onto it's side located in the front yard of 31 Birch Dr. Vehicle #1 made impact with a tree and shrubs during the accident causing minor damage to the landscape.

Driver of Vehicle #1 advised she was turning left onto Birch Dr. from Aschby Rd. when her brakes failed. Driver of Vehicle #1 relayed she attempted the turn but could not slow and struck the curb causing the vehicle to over turn.

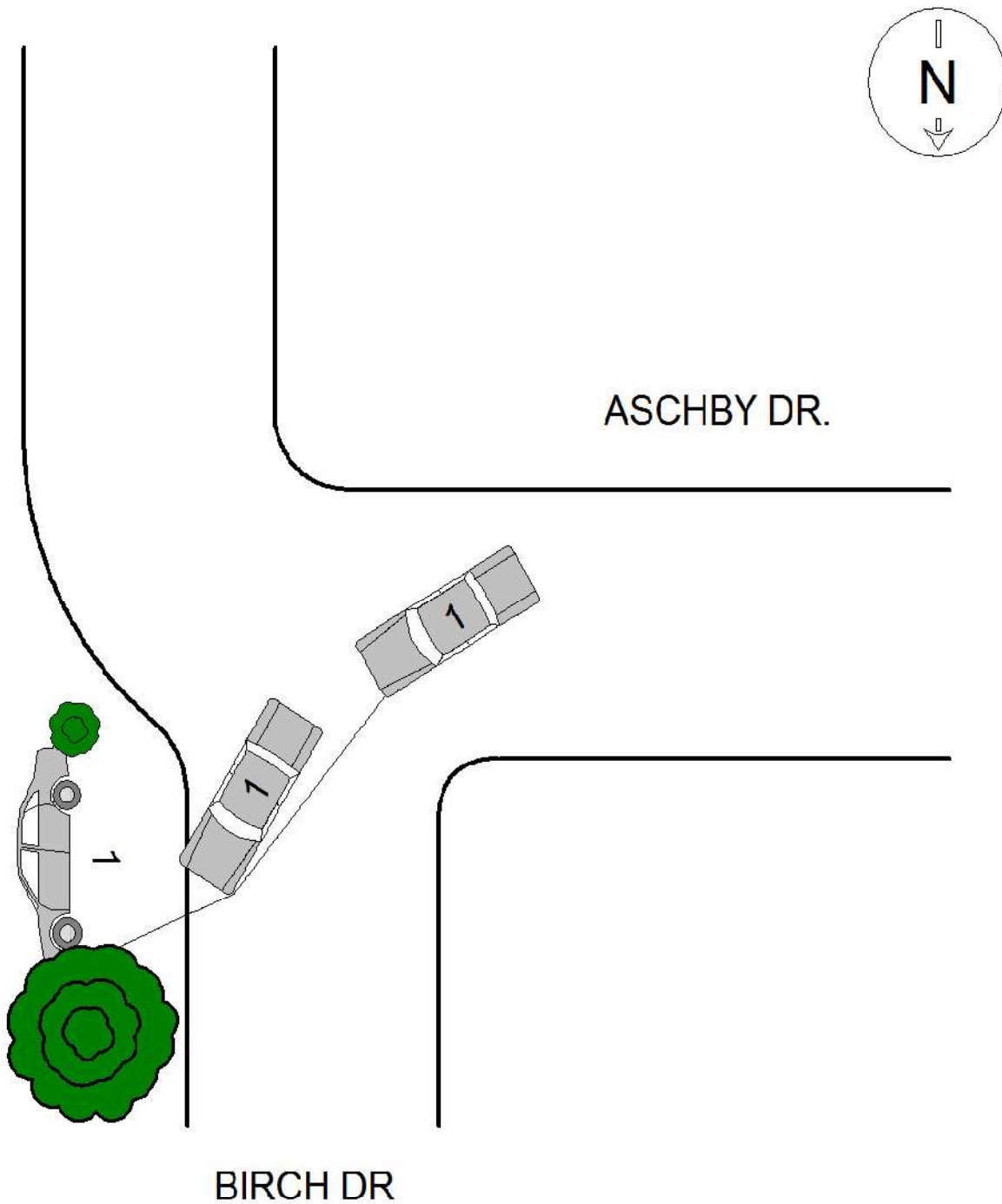
