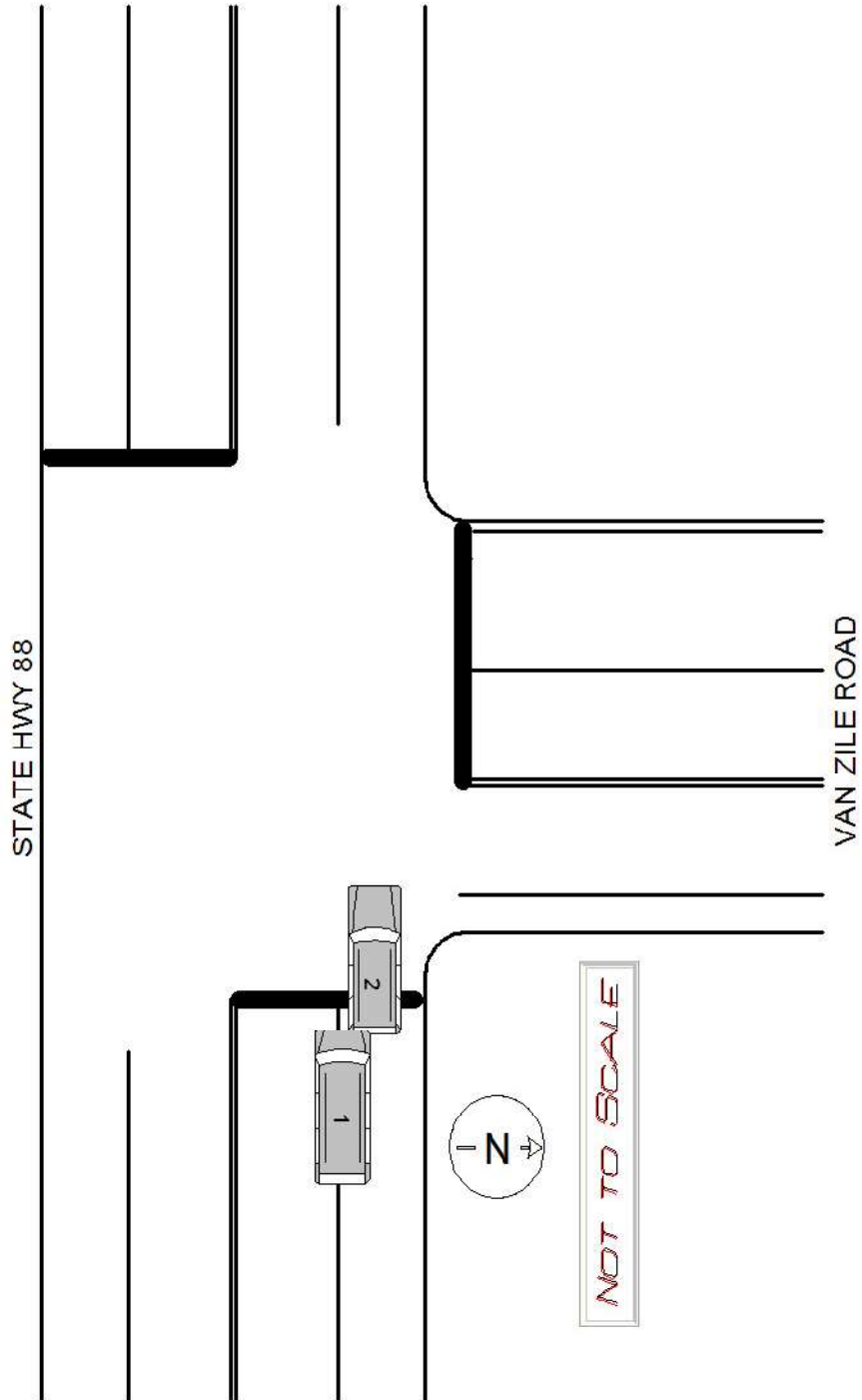

145. Crash Description/Narrative Vehicle #2 State Highway 88 westbound, stopped for traffic at green signal to make right turn onto Van Zile Rd. was struck by vehicle #1. Vehicle #1 was directly behind vehicle #2 going straight ahead attempted to pass vehicle #2 on the left and collided with it. Driver #1 stated that he was not injured. He was behind vehicle #2, observed that the signal was green and vehicle #2 was stopped, but was unsure if the vehicle was turning right or going straight ahead, attempted to pass vehicle #2, and struck it. Driver #2 stated that he was not injured. He was stopped for an eastbound vehicle on State Highway 88 making a left onto Van Zile Rd., the signal was green, and he was struck by vehicle #1. The passengers of vehicle #2 stated that they were not injured. Driver #1 failed to stop behind vehicle #2 to allow it to make a right turn and attempted to pass vehicle #2 on the left causing the collision.
