145. Crash Description/Narrative

On 5/27/18 at 0827 hours Ptl. Geskey #184 and I responded to the area of 2211 RT 88 in reference to a motor vehicle crash. The caller advised she was a passer by and noticed a vehicle off the roadway into some trees.

The caller further advised that a male subject was in the driver seat shaking, and she smelled the odor of an alcoholic beverage coming from inside the vehicle.

Upon arrival we made contact with Driver 1 who was in and out of consciousness. During moments of consciousness, Driver 1 was unable to provide any information in reference to the crash. Driver 1 did not appear to Brick EMS arrived on scene and transported Driver 1 to Ocean Medical Center, where he was later charged with DWI. (See Ptl. Geskey's Report)

My on scene crash investigation concluded the following:

Vehicle 1 was traveling west on RT 88 approaching Burnt Bridge Ave when it veered off into the right shoulder.

Vehicle 1 then over corrected to the left and spun approximately 180 degrees into the e/b lane of RT 88. Vehicle 1's momentum then rolled it backward, over the curb and into a landscaping bed in the parking lot of the Aspen

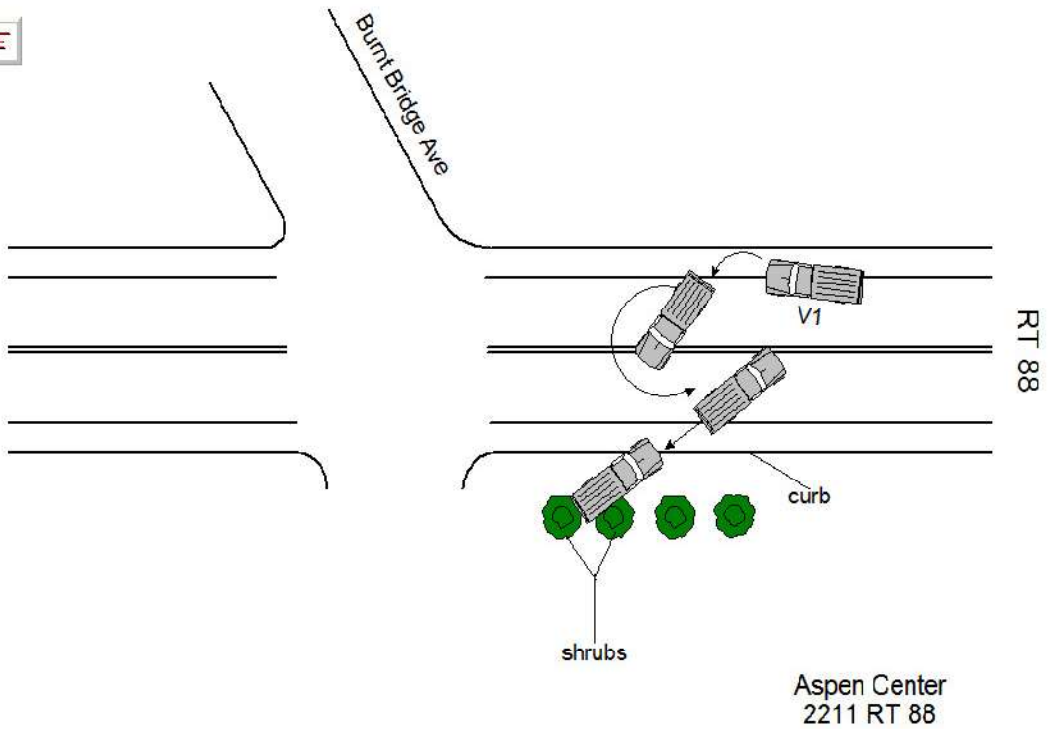
