145. Crash Description/Narrative

Investigation at the scene revealed: The driver of V2 (vehicle 2) was traveling East in the left lane on RT. 70 and was approximately 40 feet West from the intersection of RT. 70 / Van Zile Rd. The driver of V1 (vehicle 1) was traveling directly behind V2. The crash occurred when the front end of V1 collided into the rear end of V2.

On scene, I observed damage to the front end of V1 and rear end of V2. The driver of V1 stated he was not paying attention and did not have enough time to brake before colliding into the rear of V2. Both subjects involved stated they were not injured and declined first aid attention. Both vehicles were removed from the roadway prior to my arrival. V1 was towed by Point Pleasant Towing and V2 was towed by Joe's Service.

* The driver of V1 was issued to citations for careless driving (39:4-97, #158623) and driving with a suspended drivers license (39:3-40, #157849).

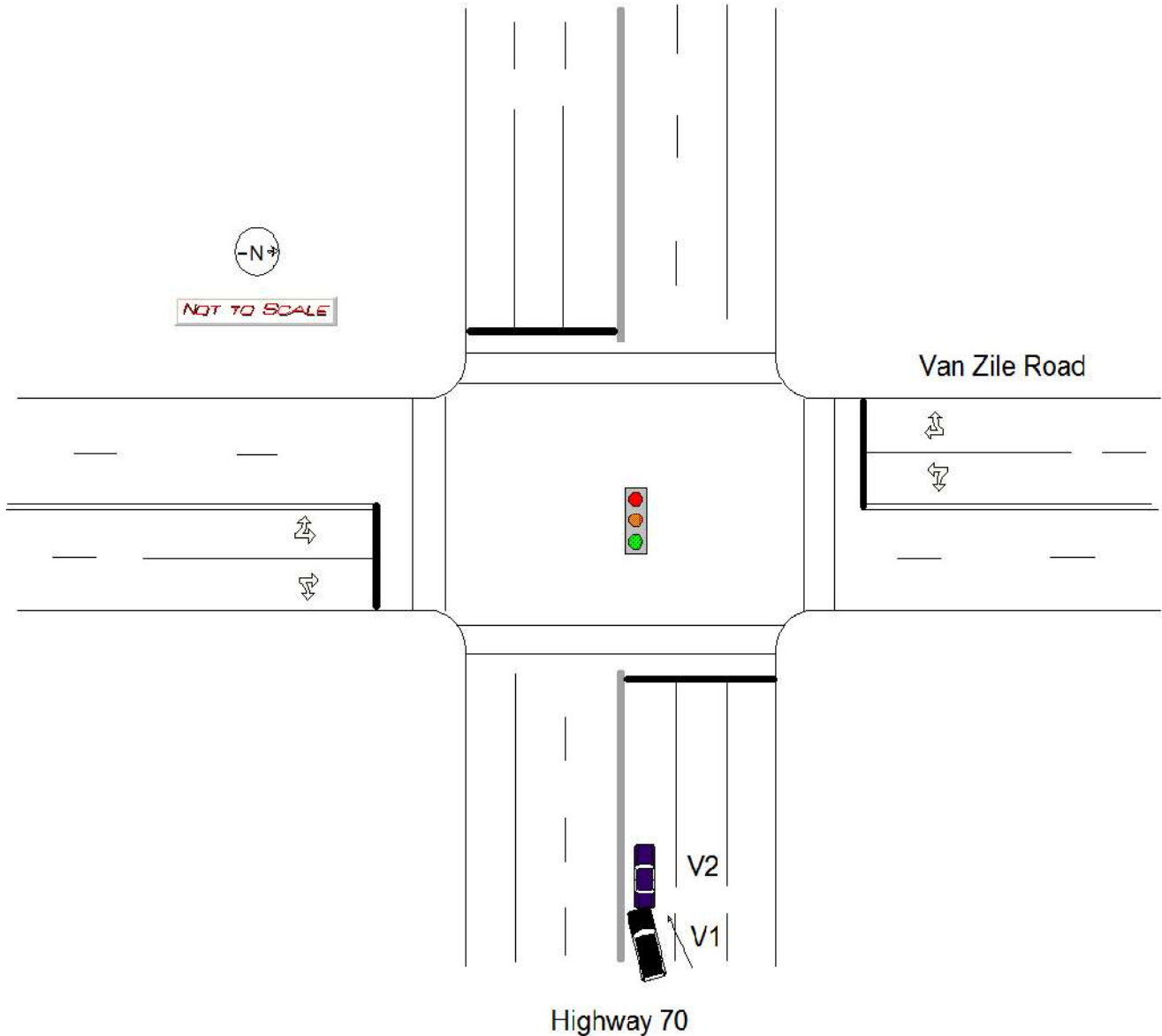
