145. Crash Description/Narrative

The driver of vehicle 1 advised she traveling west bound on Route 70 when traffic stopped short in front of her vehicle. The driver advised she attempted to stop however was unable to in time which caused the front of her vehicle to collide with the rear of vehicle 2.

The driver of vehicle 2 advised she was traveling west bound on Route 70 in stop and go traffic when the driver of vehicle 1 collided with the rear of her vehicle.

Vehicle 1 sustained damage to the front while vehicle 2 sustained damage to the rear. There were no reported injuries at the time of the accident.

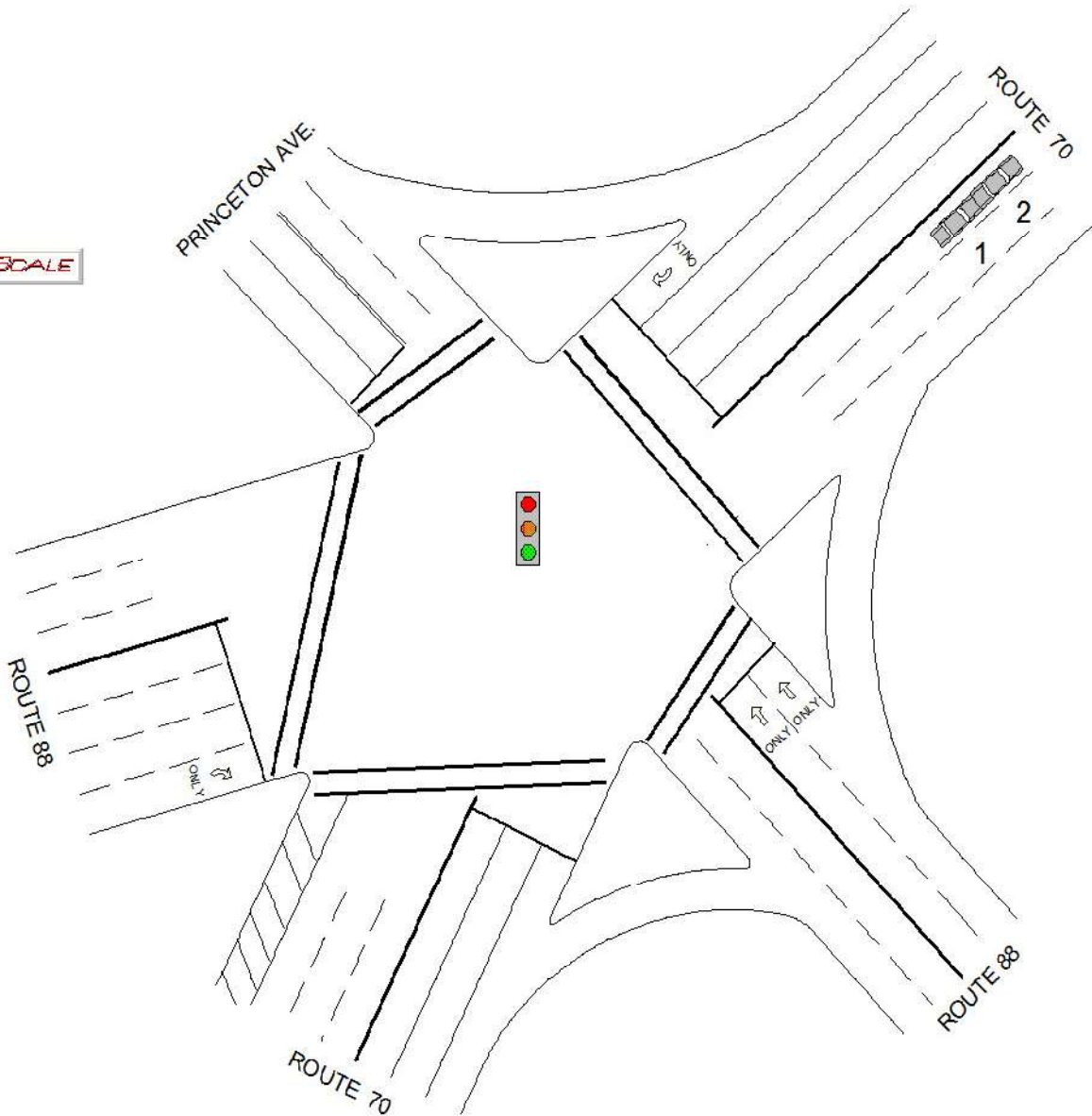
