145. Crash Description/Narrative

Vehicle #1 was attempting to park in a marked parking space in the parking lot of Chelsea Senior Living, located at 458 Jack Martin Blvd. The driver of Vehicle #1 stated that she parked too close to the unknown vehicle that was parked to the right of her vehicle. She stated that she wanted to back her vehicle up and then pull back into the marked parking space, further to the left side of the space. She stated that she mistakenly left her vehicle in drive as she wanted to back up then depressed the gas pedal. Her vehicle then pulled forward and struck the curb in front of the vehicle. The vehicle continued forward and struck several plants and small shrubs before colliding with a brick retaining wall. The impact broke the brick wall in several places and it was pushed forward onto a grass area in front of it.

The driver of Vehicle #1 advised that she was not injured. Vehicle #1 had moderate damage to it's front end and possible frame damage. The owner of Vehicle #1 responded to the scene and contacted his own towing company to remove the vehicle.

I spoke to a representative of Chelsea Senior Living (Diane Dwulet) and we spoke about the property damage caused by Vehicle #1.

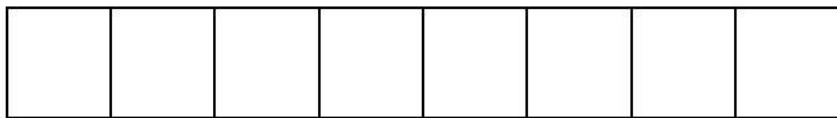

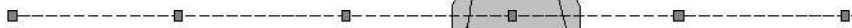
144 Crash Diagram (NOT TO SCALE)

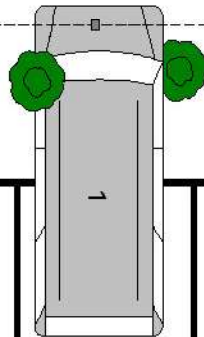

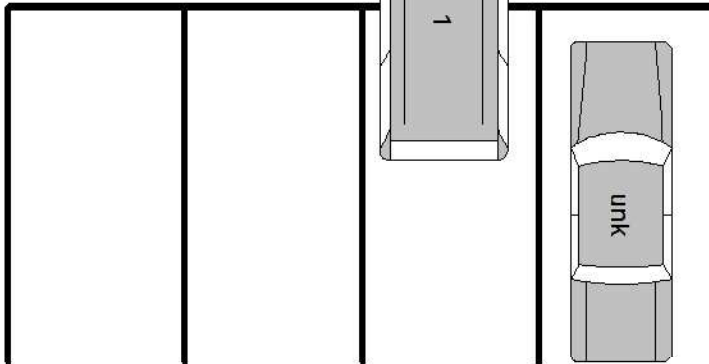
Brick Retaining Wall



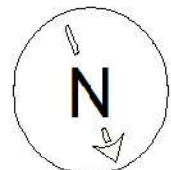
Mulched Bed
