145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction (Rear-end) collision. Driver of vehicle 2 stated she was traveling west on Route 88 in the area west of the Laurel Square Shopping Plaza (1930 Route 88). Driver of vehicle 1 was traveling directly behind vehicle 2. Driver of vehicle 2 stated she began stopping due to the volume of traffic in front of her on Route 88 W.

As vehicle 2 was stopping, the driver of vehicle 1 stated she observed vehicle 2 begin to stop however, the driver of vehicle 1 stated she was unable to stop in time causing the front end of vehicle 1 to crash into the rear of vehicle 2. Both vehicles sustained damage and were driven from the scene. No injuries were reported. Driver of vehicle 1 is at fault for the crash and was issued a summons for 39:4-97 (1506-E18-2703).
