145. Crash Description/Narrative

Vehicle #02 Was traveling Southbound on Burrsville Road and stopped at the stop sign at the corner of Burrsville Rd. and Route 88. Vehicle #01 was traveling directly behind vehicle #02. Vehicle #01 struck vehicle #02 while it was stopped at the stop sign.

Driver #02 stated she was stopped at the stop sign on Burrsville Road just prior to Route 88. Driver #02 stated she began to roll forward in order to check traffic heading Eastbound on Route 88 and was struck from behind. Driver #02 advised her neck was sore but did not wish to have EMS respond to the scene.

Driver #01 stated while approaching the stop sign on Burrsville Road he believed the vehicle in front of him was proceeding forward onto Route 88. Driver #01 stated he began looking to the right in order to check for oncoming traffic on Route 88 and began driving forward. Driver #01 stated he then struck vehicle #02 from behind. No other injuries were reported on scene. Both vehicles were driven away from the scene with minor damage.

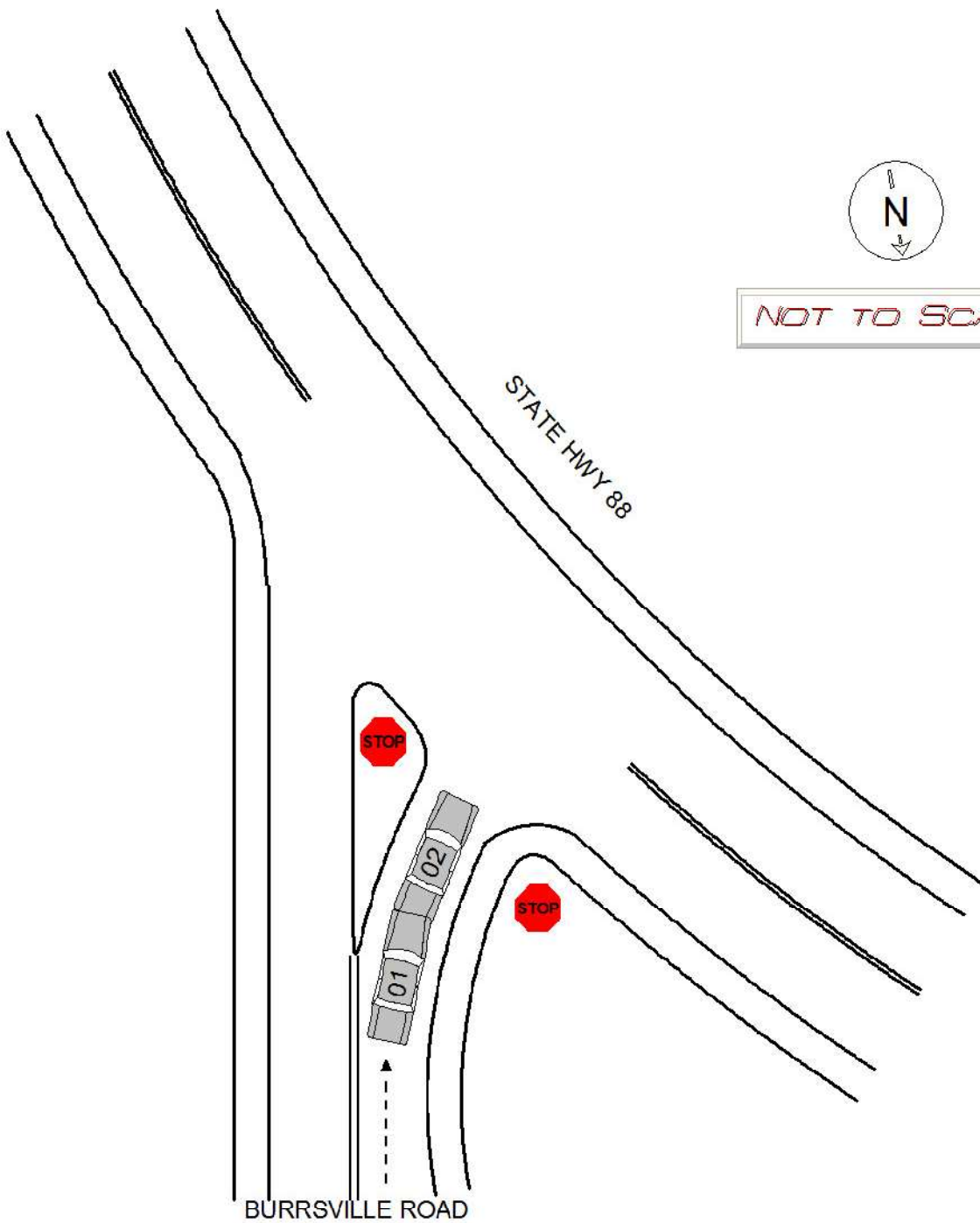
