145. Crash Description/Narrative

On April 28, 2018 at 1539 hours, I was patrolling the area of Route 88 when I approached a motor vehicle crash in the area of 1672 Route 88 (Speedway Gas Station). I observed vehicle #1 having right middle damage to the vehicle and vehicle #2 had front left damage.

Driver #1 explained she was making the left turn into the Speedway Gas Station when she observed a pedestrian crossing. After the pedestrian crossed she attempted to turn in the gas station. At that time, she failed to check for traffic coming from the opposite direction causing vehicle #2 to crash into the right side of her vehicle.

Driver #2 explained he was traveling on Route 88 when he observed vehicle #1 attempting to make the left turn into the gas station. At that time, vehicle #2 could not stop in time causing him to crash into her vehicle causing front left damage.

During my investigation, vehicle #1 was at fault for not checking for traffic. There were no injuries. Vehicle

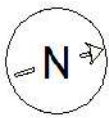

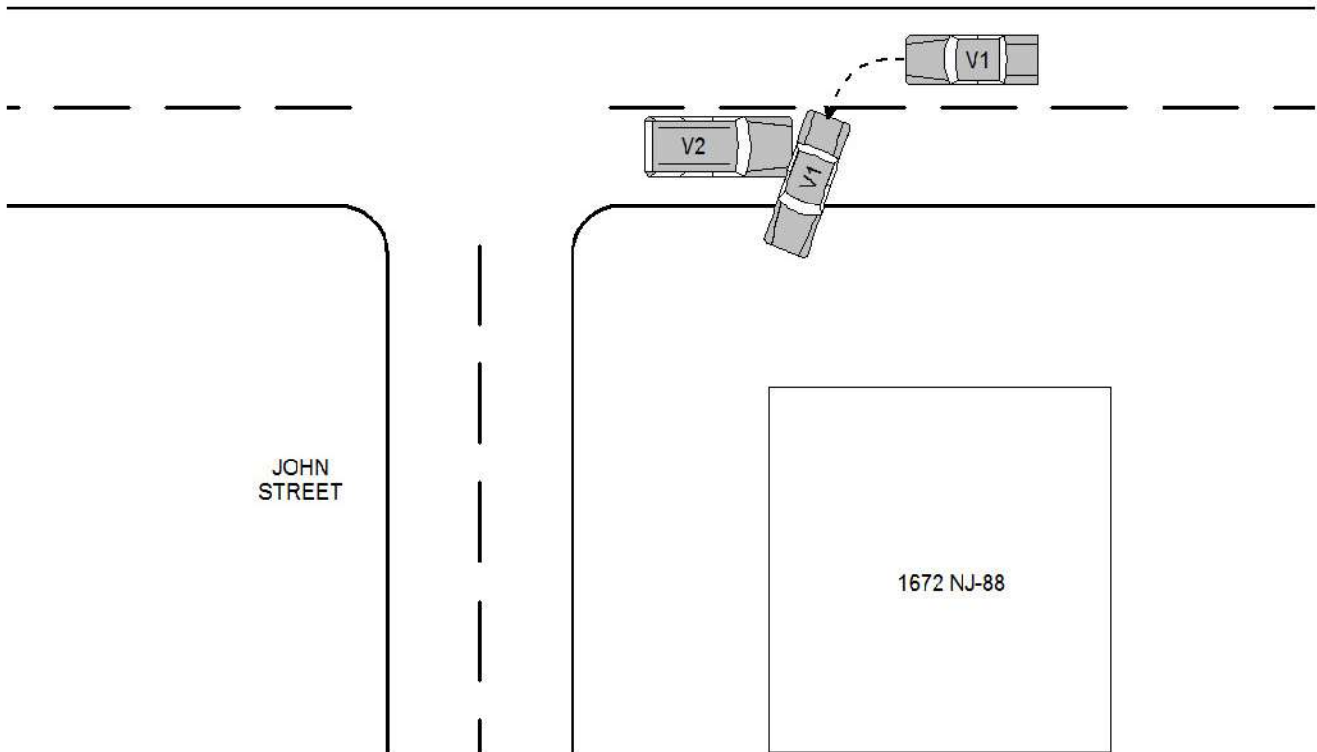
