145. Crash Description/Narrative

Vehicle 1 was traveling directly behind vehicle 2 on Route 88 west in the area of Truman Drive. Vehicle 1 rear ended vehicle 2 which was stopped in traffic.

Driver 1 stated she was traveling west on Route 88 in stop and go traffic just east of Truman Drive. Driver 1 stated she was hitting the brakes and she was unable to stop in time causing her to rear end vehicle 2.

Driver 2 stated he was stopped in traffic, west on Route 88 when vehicle 1 rear ended him.

Investigation revealed that the cause of the crash was due to driver 1 following too closely behind vehicle 2.

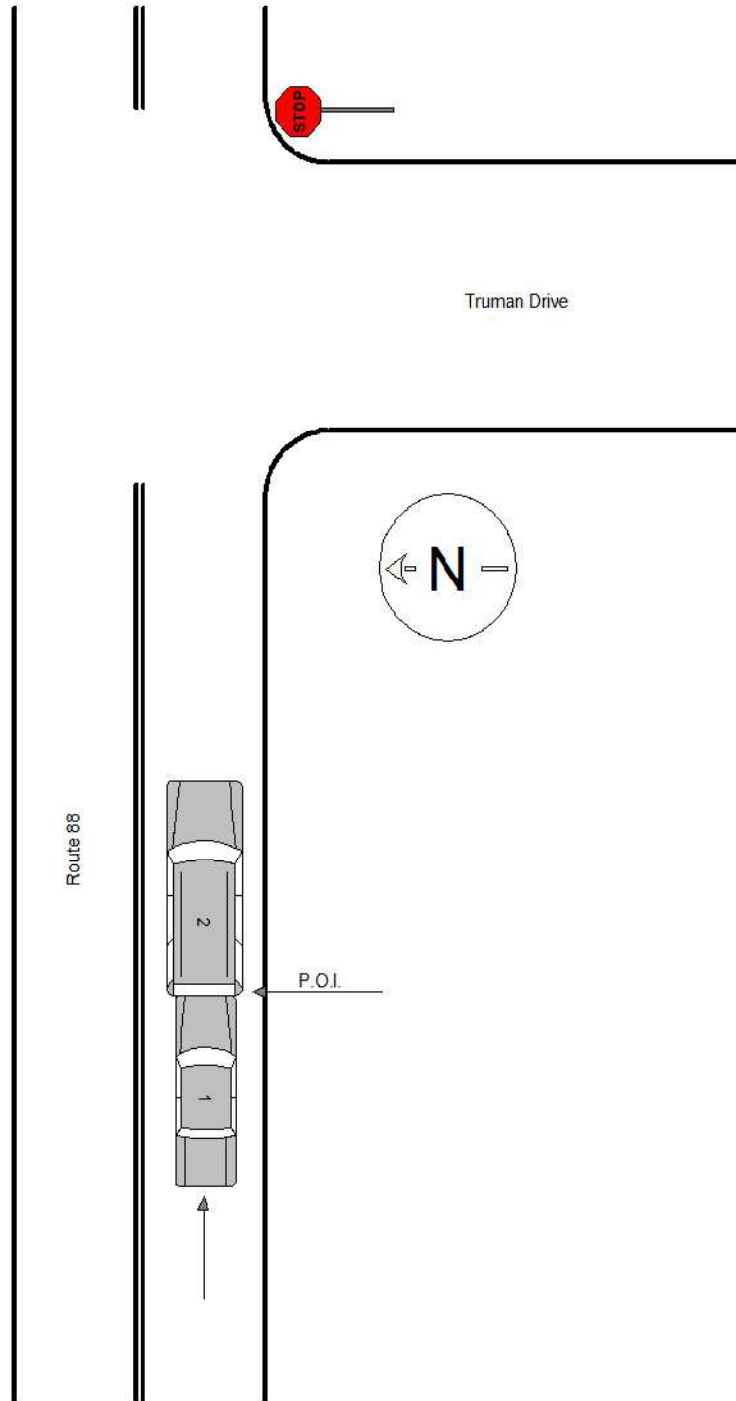
