145. Crash Description/Narrative

Vehicle 2 was traveling east on RT 88, in the area of Barb Lane. Vehicle 1 was traveling on RT 88 behind Vehicle

2. Vehicle 2 slowed down to make a right turn into the parking lot of Camp Mall (1905 RT 88) and was struck from

behind by Vehicle 1.

Driver 2 stated while traveling east on RT 88, west of Barb Ln, she observed Vehicle 1 in her rear view mirror,

but there were several vehicles between her's and Vehicle 1. Driver 2 stated she observed Vehicle 1 aggressively

pass those vehicle's before ending up directly behind her. Driver 2 stated when she slowed down to pull into the

Camp Mall parking lot, Vehicle 1 accelerated to pass her on the right and ended up crashing into the rear of her

vehicle.

Driver 1 stated he was traveling east on RT 88 in the area of Barb Ln when he observed Vehicle 2 stop short in

front of him prior to the entrance to Camp Mall. Driver 1 stated he had no time to react and could not avoid the

collision.

My on scene investigation determined Driver 1 to be at fault for the crash and he was subsequently issued a

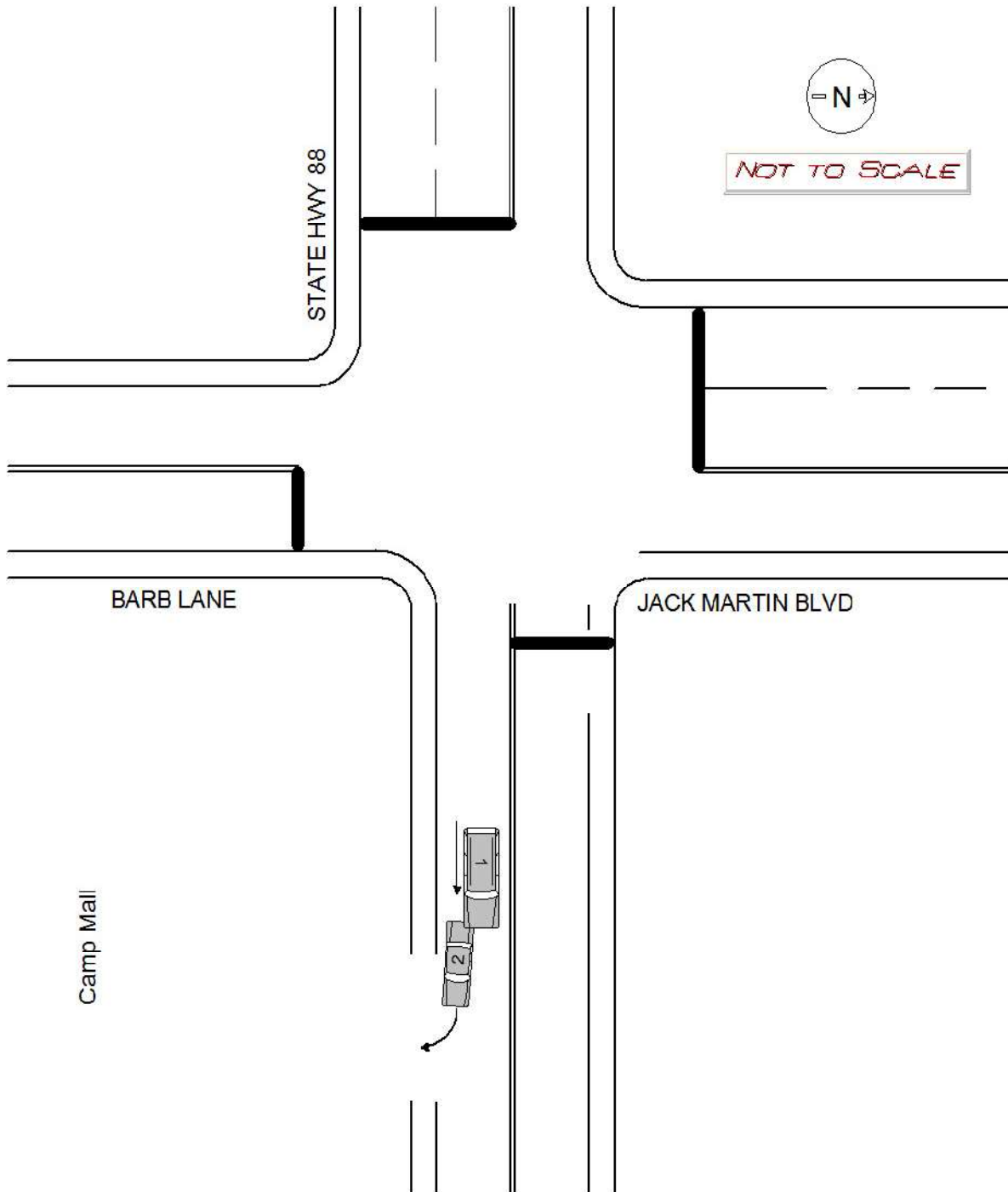
