145. Crash Description/Narrative

Vehicle one was traveling South on the access road to 1461 Rt. 88. Vehicle one made a right turn to travel West on the access road on the North side of 1461 Rt. 88. Vehicle one made the right turn wide striking vehicle two (parked legally) on the passenger side rear bumper with the front driver's side bumper of vehicle one.

Vehicle one sustained damage to the front bumper, grill and driver's side headlight. Vehicle one's airbags did not deploy. Vehicle two sustained heavy damage to the rear of the vehicle including: the rear bumper, exhaust, all rear lights, trunk, rear axle and the rear windshield was smashed.

Driver one advised that the neighbors dog ran out in front of her vehicle, causing her to take evasive action to avoid hitting it and resulted in her striking vehicle two. Driver one further stated that she is not injured and refused medical attention.

The owner of vehicle two was contacted and advised that she would like her vehicle towed. Legacy Towing responded to the scene for Rt 88 Towing and removed vehicle two in accordance with the owner's wishes.

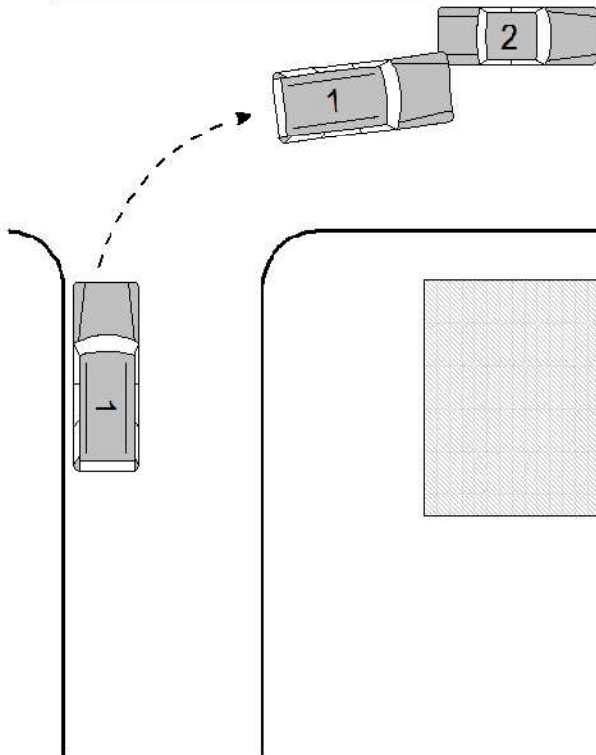
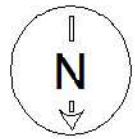
