145. Crash Description/Narrative

Vehicle 2 was stopped for traffic in the 3rd travel lane on Rt. 70 east when it was struck from behind by vehicle

1 who was also stopped in the 3rd travel lane behind vehicle 2. Driver 1 stated when he observed the traffic

light turn green and cars around him begin to move, he moved forward and struck vehicle 2 who had not moved yet.

Driver 2 stated that she was at a complete stop waiting for the cars in front of her to move at the time of

impact. Driver 1 was found to be at fault for the crash as he was following vehicle 2 too closely and for driver

inattention. Driver 1 was also issued a summons, #E182030, for driving without a license, 39:3-10. *Box 24-25

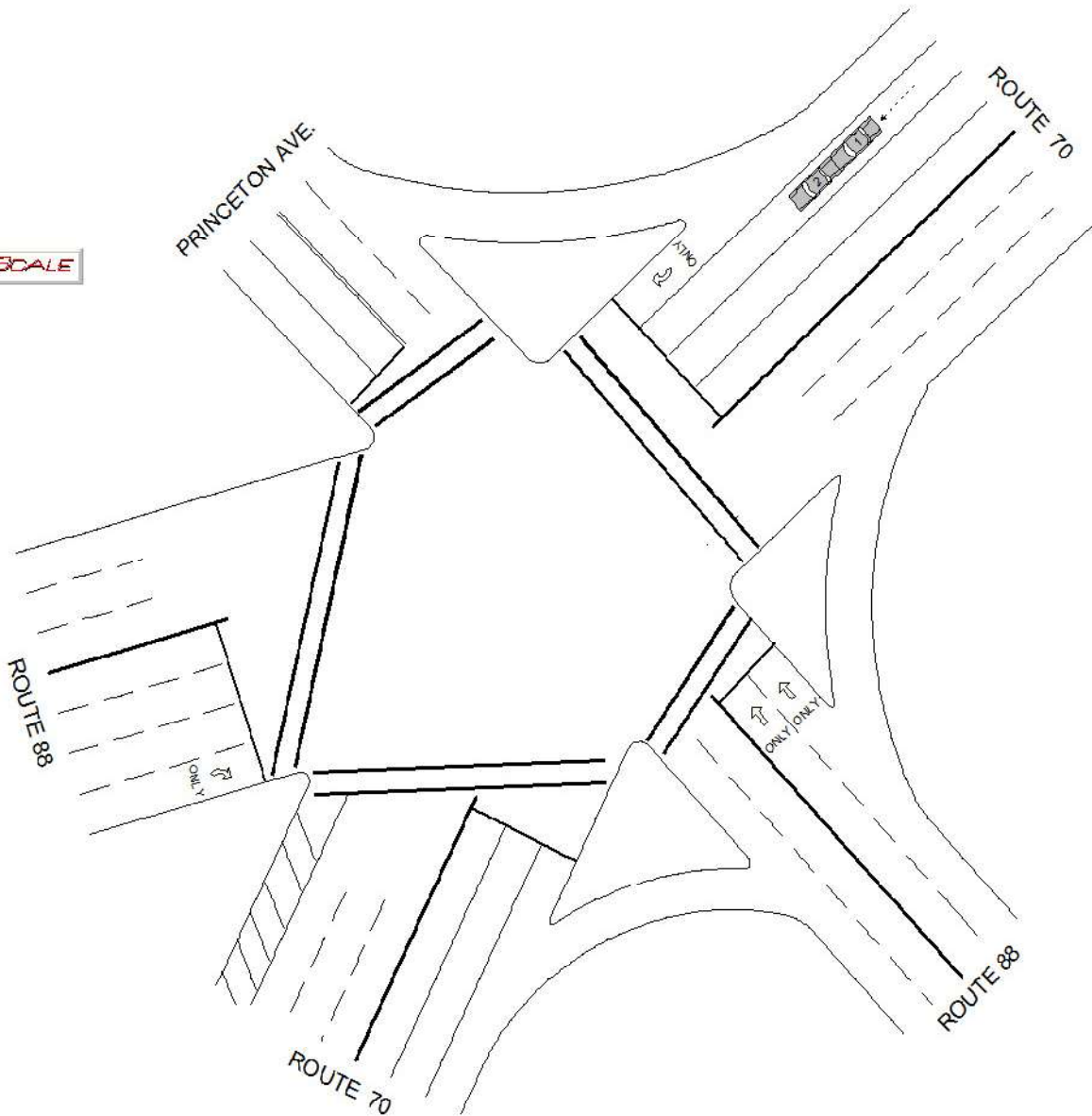
