145. Crash Description/Narrative

Vehicle 1 was traveling southbound on Van Zile Road and was attempting to make a right turn onto Route 70 westbound. Vehicle 2 was traveling westbound on Route 70, in the right lane, in the area of Van Zile Road.

The driver of Vehicle #1 stated that she had the green traffic signal while turning right onto Route 70 westbound from Van Zile Road. She stated that Vehicle #2 went through the red light while traveling westbound on Route 70. She did not see Vehicle #2 until the two vehicles struck each other. Vehicle #1 had damage to the entire front end of the vehicle.

Driver of vehicle 2 stated that while traveling straight (westbound) on Route 70 she had the green light and was traveling in the right lane because she was getting ready to take the Van Zile Road U-turn. She stated that Vehicle #1 then made a right hand turn westbound onto Route 70 with a red light, directly into the lane she was traveling in. She advised that Vehicle #1 then struck her vehicle, causing damage to the passenger side front door.

A witness to the accident who stopped stated that she observed an unknown model gray pickup truck run through the

red signal traveling on Route 70 westbound and then hit Vehicle #1 and fled the area. As a result of the MVA, Vehicle #1 then struck Vehicle #2. This statement could not be proven as there was no other damage consistent with her statement and neither of the drivers involved observed a pick-up truck. The witness completed a motor vehicle crash statement form.

Accident investigation revealed that while Vehicle #1 was turning right onto Route 70 westbound from Van Zile Rd, Vehicle #1 may not have observed Vehicle #2 traveling westbound causing Vehicle #1 to strike Vehicle #2 on the passenger side. Based on conflicting stories from both drivers and the only witness, it could not be determined who had the green signal. In an attempt to determine who was at fault in the accident, a check of surrounding businesses was conducted to see if any surveillance cameras captured the incident. This yielded negative results. No damage to either vehicle was found consistent with the witness's statement.

No injuries were reported on scene. Vehicle 1 was disabled and was removed from the scene at the driver's consent to Joe's Service Center. Vehicle 2 was driven from the scene.

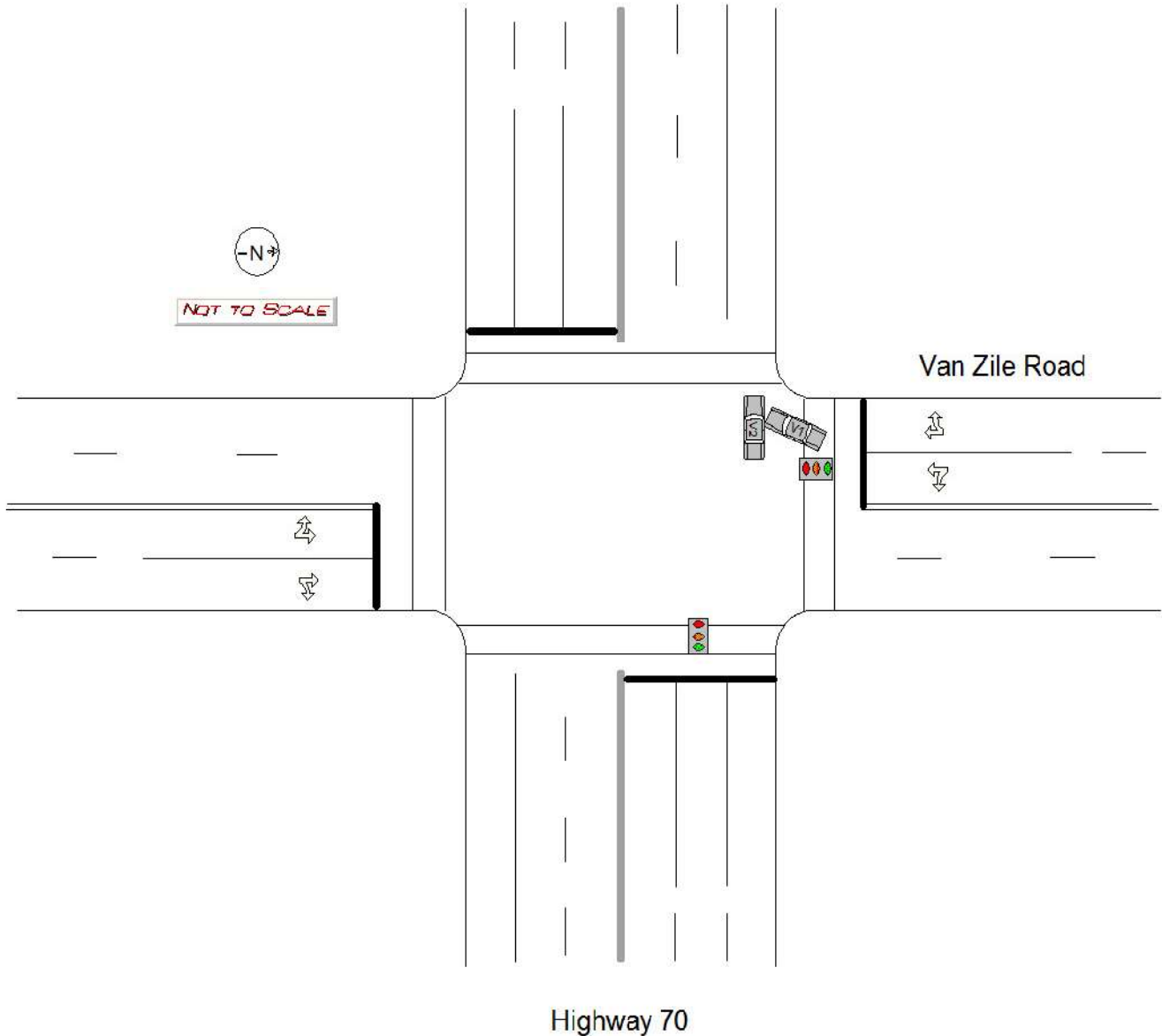
