145. Crash Description/Narrative

Vehicle 2 heading eastbound on Route 88, approaching Van Zile Road and stopping for the amber traffic light.

Vehicle 1 traveling eastbound on Route 88, directly behind Vehicle 2.

Driver 2 stated she saw the traffic light change to amber and she stopped for the impending red traffic light. When she came to a stop, she was struck from behind by Vehicle 1. Driver 2 had a complaint of minor neck pain.

Driver 1 stated he was following Vehicle 2, which was being operated by his daughter. Driver 1 stated he was not anticipating her stopping for the amber traffic light. When Driver 1 saw her stopping, he began attempting to stop. Driver 1 was unable to stop before striking the rear of Vehicle 2.

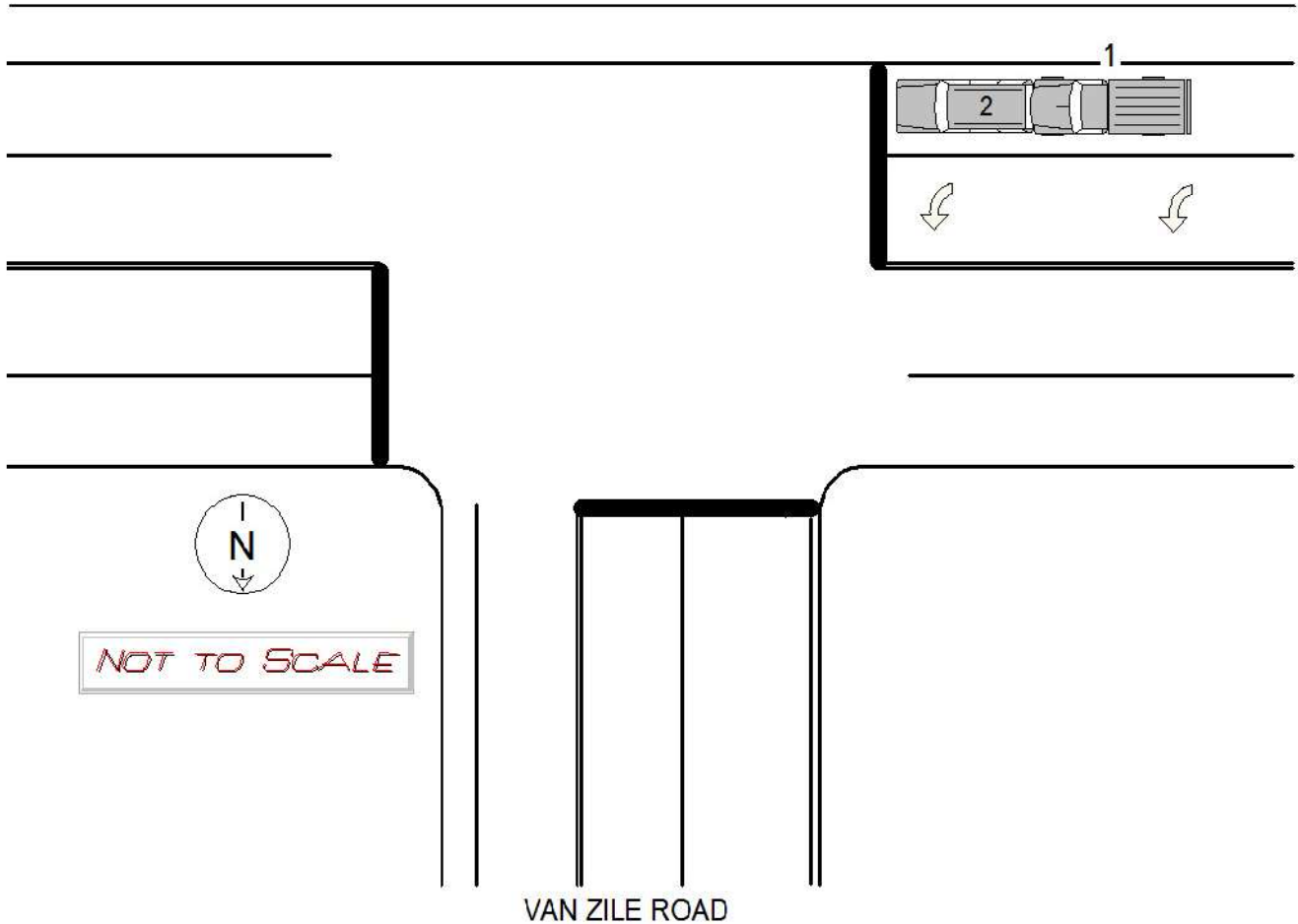
