145. Crash Description/Narrative

Vehicle 2 was traveling westbound on Rt 88. Vehicle 1 was in the parking lot of the Speedway, 1872 Rt 88. Vehicle 1 conducted a left turn onto Rt 88 to travel eastbound. Vehicle 1 pulled into traffic directly in front of vehicle 2. A right angle collision then occurred.

The driver of vehicle 1 advised me of the following:

She was stopped at the stop sign in the parking lot of 1872 Rt 88 waiting to conduct a left turn. The roadway appeared clear so she proceeded with her turn to travel eastbound on Rt 88. Vehicle 2 was never observed and a collision then occurred.

The driver of vehicle 2 advised me of the following:

She was traveling westbound on Rt 88 approaching the Speedway, 1872 Rt 88. Vehicle 1 then pulled out in front of her. Driver 2 attempted to stop, however a collision was unavoidable.

The driver of vehicle 1 is found to be at fault for the collision and has been issued a Summons for Careless Driving (39:4-97) on summons E18 1485. The passenger of vehicle 2 had a complaint of pain and a minor laceration

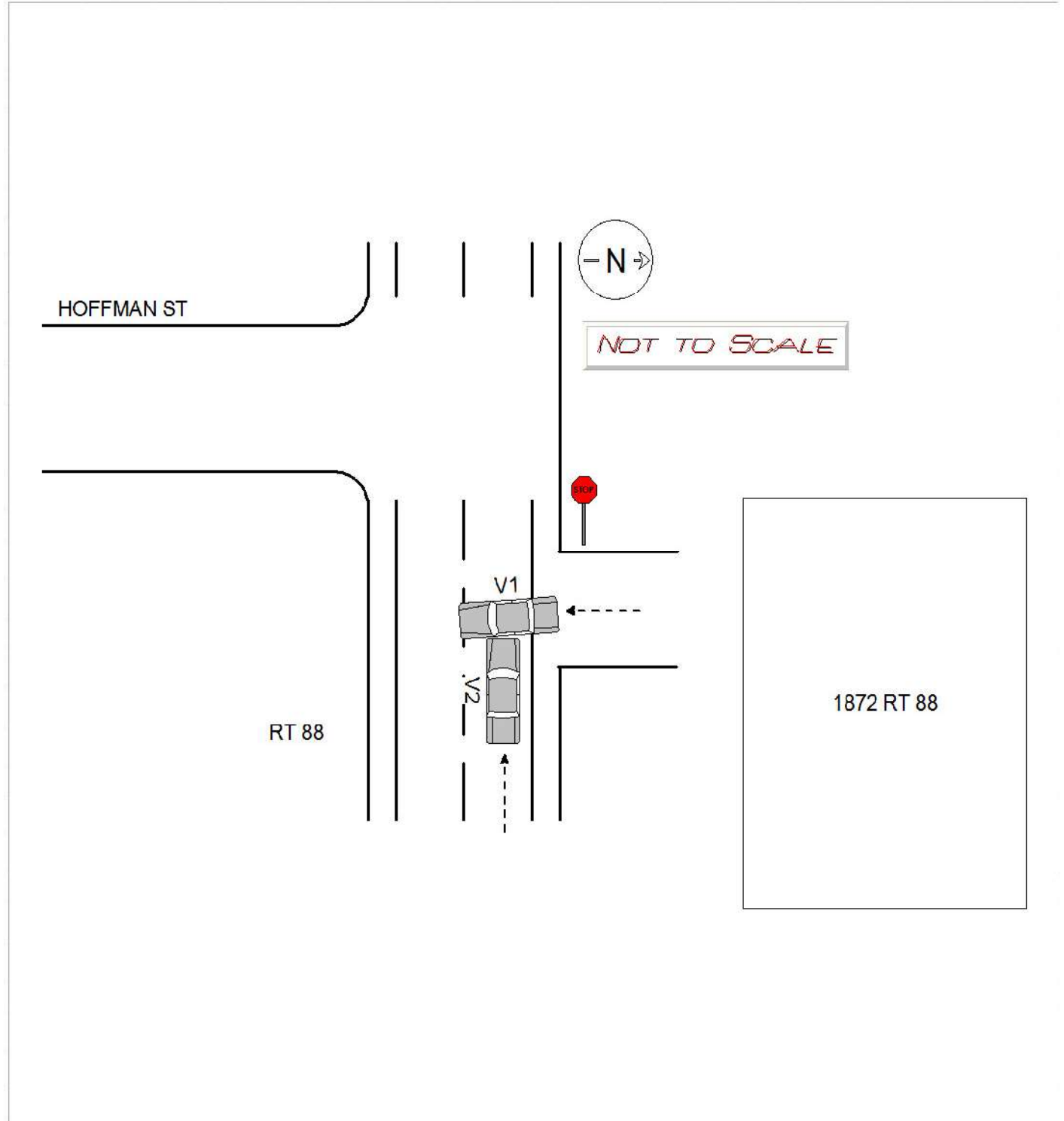
