145. Crash Description/Narrative

While stopped on Rt 88 east for the traffic light at Rt 70 in the right lane, Vehicle 01 rolled into the rear of Vehicle 02.

Driver of Vehicle 01 stated he was in the right lane on Rt 88 east behind Vehicle 02 waiting for the traffic signal at Rt 70 when his vehicle rolled into the rear of Vehicle 02.

Driver of Vehicle 02 stated he was in the right lane on Rt 88 east at the intersection of Rt 70 waiting for the red light when he was tapped in the rear by Vehicle 01.

Both Vehicles were moved prior to Police arrival.

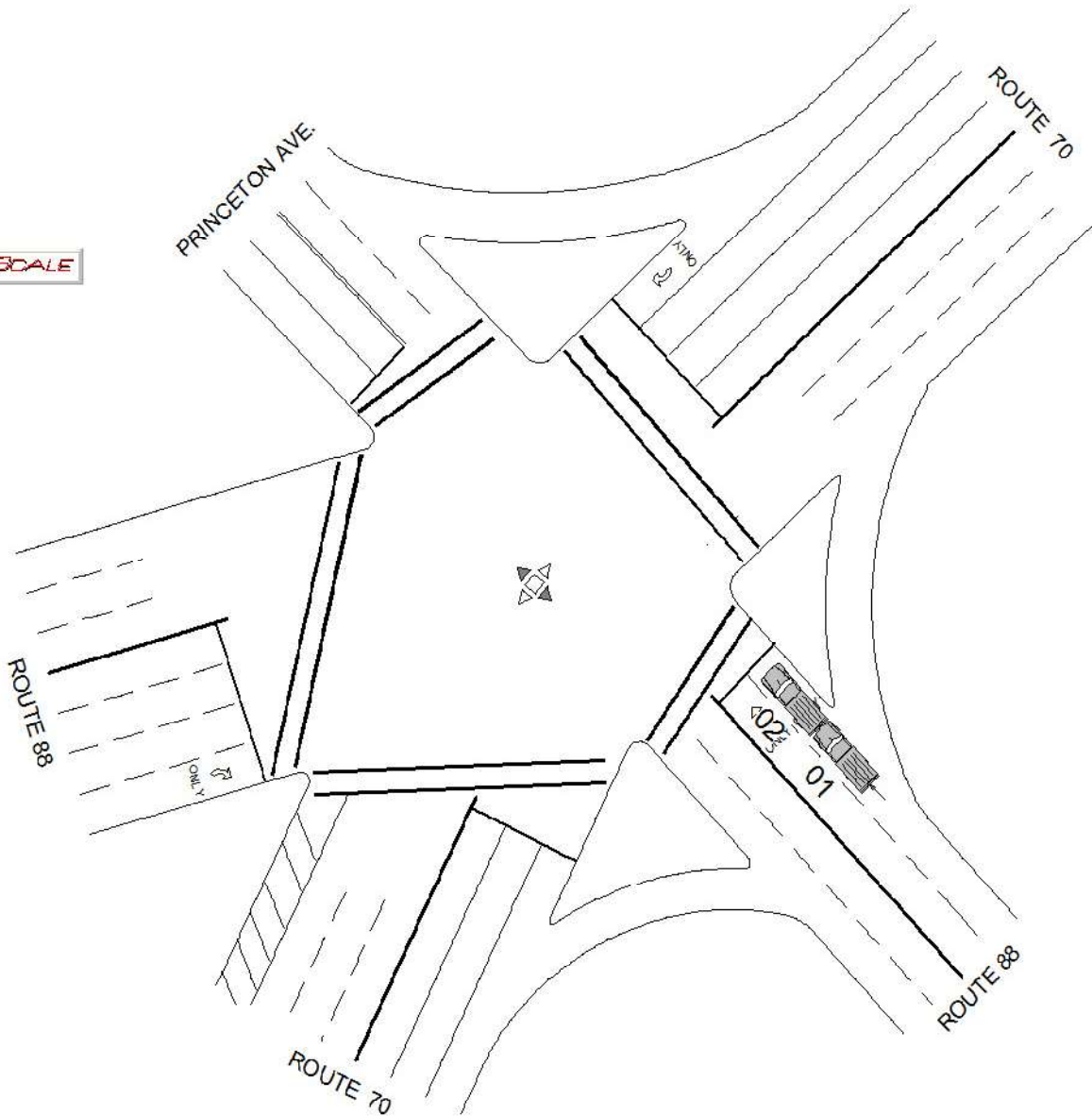
